has been approved subject to the conditions incorporated in the reference of 11 cited

2) The applicant has accepted to the conditions stipulated by CMDA vide in the reference 7th cited and has remitted the necessary charges in Challan No. 5614 dated 25-7-04 including Security Deposit for building Rs. 2,05,000/- (Rupees two lakhs and five thousand only) Balance Security Fee Rs. 20,000/- (Rupees twenty thousand only), and DD of Rs. 125,000/- (Rupees one lakh and twenty five thousand only) for Display Board Rs. 10,000/- (Rupees Ten thousand only) in cash and furnished Bank Guarantee No. CTE/MAN/2005/007 dt 25-7-04 from The Centurion Bank Ltd, Anna Nagar West, Chennai Branch, for security deposit for building Rs. 8,40,000/- (Rupees Eight lakhs and four thousand only) as ordered in the WP No. 2259601 dated 14-7-05.

This Bank Guarantee is valid till 24-07-2010

3) The Local body is requested to ensure Water supply and Sewerage disposal facility for the proposal before issuing building permit.

4) The Up Flow Filter to be initially maintained by the Promoter till the Residents' Association is formed and take over it.

5) Non provision of Rain Water Harvest structure as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.

6) Two sets of approved plans numbered as Planning Permit No. BSL-Bldg 323 A/614/05

dated - 8-05 are sent herewith. The Planning Permit is valid for the period from - 9-05 to - 9-08

7) This approval is not final. The applicant has to approach the ~~Municipality~~/ Panchayat Union/ ~~Town~~ Panchayat / Township for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
