The Planning Permission Application received in the reference ...1st cited for the construction of regularisation of B.F + G+ft + 2 floors office cum Residential (with 2 D.U's at 2nd floor) building at New door no. 32, Khader Nawaz Khan Street, R.S. no. 58/44 and 58/124, Block no. 12 of Nungambakkam Village, Chennai, has been approved subject to the conditions incorporated in the reference ...2nd cited.

2) The applicant has accepted to the conditions stipulated by CMDA vide in the reference 2nd cited and has remitted the necessary charges in Challan No. C-7127 dated 03/10/05 including Development Charges for land and building Rs. 20,000/- (Rupees Twenty thousand only), Regularisation Charges Rs. (Rupees) Open Space Reservation Charges Rs. (Rupees) Security Deposit for building Rs. 2,000/- (Rupees Two Thousand only) in cash and Display Deposit of Rs. 10,000/- (Rupees Ten thousand only) and SD for septic Tank Rs. (Rupees) in Cash.

The applicant had remitted the DC = 21,000/-; S.D = 20,000/-; S.D = 82,000/- and display deposit 12,000/-
with ch. no. 36019 dt 13/9/04, which has been adjusted for this revised proposal.
- 3) (a) The applicant has furnished a Demand Draft in favour of M.D., CMWSSB for a sum of Rs. 2,488/- (Rupees Two thousand and eight hundred and eighty eight only) towards water supply and sewerage infrastructure improvement charges in his letter dt. 3/10/2005 while obtaining earlier PP vide Dr. BCI/22088/64 dt 28/9/2004. The applicant has furnished the DD in favour of M.D., CMWSSB for sum of Rs. 1,04,512/- D.D.no. 693487 dt 9/9/2004, Canara Bank Thamby Chetty St, ch-1 which has been adjusted for this revised proposal.
- b) With reference to the sewerage system the promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he/she can commence the internal sewer works.

c) In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for the purpose of drinking and cooking only and confined 5 persons per dwelling at the rate of 10 lped. In respect of requirements of water for other uses, the promoter has to ensure that he/she can make alternate arrangements. In this case also, the promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermetically sealed off with properly protected vents to avoid mosquito menace.

4) Non-Provision of Rain Water Harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules and enforcement action will be taken against such development.

5) Two copies of approved plans numbered as Planning Permit No. B /
Spl.Bldg. / 379 / 2005 / 200 dated - 10 - 2005 are sent herewith. The Planning
Permit is valid for the period from - 10 - 2005 to - 10 - 2008

6) This approval is not final. The applicant has to approach the Township for issue of building permit under the Local Body Act, only after which the proposed construction can be commenced.
