The applicant has accepted to the conditions stipulated by CMDA vide in the reference 2nd cited and has remitted the necessary charges in Challan No.C.12873, dt.21.06.06 including Development charges for land and building Rs.21.500/- (Rupees twenty one thousand and five hundred only), Security Deposit for building Rs.83,500/- (Rupees eighty three thousand and five hundred only) and Display Deposit of Rs.10,000/- (Rupees ten thousand only).
