The Planning Permission Application received in the reference cited for proposed construction of Industrial Shed and installation of machineries with a total 150 H.P. in the site bearing S.No.820/23 of Kuthambakkam village has been approved subject to the conditions incorporated in the reference 2nd cited.

2. The applicant has remitted the following charges.

Development Charges : Rs.21,000/- (Rupees twenty one thousand only)

Scrutiny Fees : Rs. 500/- (Rupees five hundred only)

Regularisation Charges : Rs.15,500/- (Rupees fifteen thousand and five hundred only)

3. It shall be ensured that all wells, overhead tank and septic tanks are hermetically sealed with proper protected vents to avoid mosquito menace.

4. Non provision of Rain Water Harvest structures as shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of Development Control Rules, and enforcement action will be taken against such development.

5. Two copies of approved plans, numbered as Planning Permit No.C/997/33/2005, dated 28.10.2005 is sent herewith. The Planning Permit is valid for the period from 28.10.2005 to 27.10.2008.

6. This approval is not final. The applicant has to approach the Panchayat Union for issue of building permit under the Local Body Acts, only after which the proposed construction can be commenced.
