The Planning Permission Application received in the reference 1st cited for the proposed construction of Basement Floor + Stilt Floor + 6 floors (IT building) at Plot No.DP-12A(SP) Thiru-vi-ka Industrial Estate, Guindy, Chennai-32 has been approved subject to the conditions incorporated in the reference 5th to 9th, 16th, 18th, 21st and 22nd cited.

- 2. The applicant has remitted the following charges:-
- i) Development charge for land and building under Sec.59 of the T&CP Act, 1971

 ii) Balance Scrutiny fee Rs.1,600/-(Rupees One lakh and seventy five thousand only)

In Chalan no.c-18659, Dated:21.3.2007 accepting the conditions stipulated by CMDA vide in the reference 22nd cited. In respect of payment of IDC, the applicant has furnished demand draft for an amount of Rs.3,92,000/- (Rupees Three lakhs and ninety two thousand only) towards Infrastructure Development Charges payable to CMWSSB (DD No.260908, Dated:21.3.2007)

3. The promoter has to submit the necessary sanitary application directly to Metro Water and only after due sanction he can commence the internal sewer works.

In respect of water supply, it may be possible for Metro Water to extend water supply to a single sump for the above premises for purpose of drinking and cooking only and confined to 5 persons per dwelling at the rate of 10 lpcd. In respect of requirement of water for other uses, the promoter has to ensure that he can make alternate arrangements. In this case also, the Promoter should apply for the water connection, after approval of the sanitary proposal and internal works should be taken up only after the approval of the water application. It shall be ensured that all wells, overhead tanks and septic tanks are hermitically sealed of with properly protected vents to avoid mosquito menace. Non provision of rain water harvest structures shown in the approved plans to the satisfaction of the Authority will also be considered as a deviation to the approved plans and violation of DCR and enforcement action will be taken against such development.

- 4. Two sets of approved plans numbered as Planning Permit No. C/PP/MSB&IT / 16 A to D /2007 dated .04.2007 (Planning Permit No.002343) are sent herewith. The Planning Permit is valid for the period from .04.2007 to .04.2010.
- 5. This approval is not final. The applicant has to approach the Commissioner, Corporation of Chennai for issue of building permit under the Chennai City Municipal Corporation Act, only after which the proposed construction can be commenced.
