- iv) Open Space Reservation Charges (i.e. equivalent land cost in lieu of the space to be reserved and handed over as per DCR 19 (b)I (VI)19(b)-II (vi)17(a)(9) : Rs. - (Rupees)

v) Security Deposit (for the proposed Development)

: Rs. 10,000/-
