- i. Security Deposit are refundable amount without interest on claim, after issue of completion certificate by CMD. If ther any deviation /violation/change of issues of any part or whole of the building/site to the approved plan, Security Deposit will forfeited.
- ii. Security Deposit for display board is refundable, when the display board as prescribed in the format is put up in the site ur reference. In case of default, Security Deposit will be forfeited and action will be taken to put up the Display Board.
- iii. In the event of the Security Deposit is not claimed within a period of 5 years from the date of remittance, the Security Dep shall be forfeited without any further notice.
- 2)Payment received after 30 days from the date of issue of this letter attracts penal interest at the rate of 6% per annum (i.e. 0. per month) for item No.viii and for other items 12% per annum (i.e. 1% per month) for every completed month from the date of issuthis letter. This amount of interest shall be remitted along with the charges due (however no interest is collectable for Security Depo If the due date for payment of charges to CMDA falls on public holidays, the next working day shall be taken as due date.
  - 3) The papers would be returned unapproved if the payment is not made within 60 days from the date of issue of this letter.
  - 4) You are also requested to comply the following:
  - a) The measures stipulated by CMDA for rain water conservation to be adhered
  - b) Furnish the letter of your acceptance for the following conditions stipulated by virtue of provisions available under DR 4(2)
- i)The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without p sanction. Construction done in deviation is liable to be demolished.
- ii)In cases of special Buildings, group Developments, a professionally qualified Architect Registered with the Counci Architects or class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names /addresses consent letters should be furnished.
- iii) A report in writing shall be sent to CMDA by the Architect/class –I licensed surveyor who supervises the construction before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to CMDA when building has reached up to plinth level and thereafter every three months at various stages of the construction/development certify that the work so far completed is in accordance with the approved plan.

The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/them and owner/developer has been cancelled or the construction is carried out in deviation to the approved plan.

- iv) The owner shall inform CMDA of any changes of the licensed Surveyor/Architect. The newly appointed Licen Surveyor/Architect shall also confirm to CMDA that he has agreed for supervising the work under reference and intimate the stage construction at which he has taken over. No Construction shall be carried on during the period intervening between the exist of previous Architect/Licensed surveyor and entry of the newly appointed.
- v) On completion of the construction, the applicant shall intimate CMDA and shall not occupy the building or permit it to occupied until a completion certificate is obtained from CMDA.
- vi) While the applicant makes application for service connection such as Electricity, Water supply, Sewerage, he/she she enclose a copy of the completion certificate issued by CMDA along with his application to the concerned Department Board/Ageincy
- vii) When the site under reference is transferred by way of sale/Lease or any other means to any person before completion of construction, the party shall inform CMDA of such transaction and also the name and address of the persons to whom the sit transferred immediately after such transaction and shall bind the purchaser to those conditions to the planning permission.
  - viii) In the open space within the site, trees should be planted and the existing trees preserved to the extent possible.
- ix) If there is any false statement suppression or any misrepresentations of action the application planning permission wil liable for a cancellation and the development made, if any will be treated as unauthorized.
  - x) The new building should have mosquito proof for overhead tanks and wells.
  - xi) The sanction will be void abinitic if the conditions mentioned above are not complied with
  - xii) Rain water conservation measures notified by CMDA should be adhered to strictly:
- a)Undertaking (in the format prescribed in Annexure-III to DR) a copy of it enclosed in Rs.10/- stamp paper duty executed by the land owners, GPA Holders, builders and promoters separately. The undertakings shall be duly attested by a Notary Public.

b)Details of the proposed development duly filled in the format enclosed for display at the site in cases of Special Buildings Grow Developments.

- 5) The issue of planning permission depends on the compliance/fulfilment of the conditions/payments stated above. acceptance by the Authority of the pre-payment of the Development Charges and other charges, etc. shall not entitle the person to planning permission, but only refund of the Development Charges and other charges(excluding Scrutiny Fee) in case of refusal of permission for non-compliance of the conditions stated above or any of the provisions of DR, which has to be complied before get the planning permission or any other person provided the construction is not commenced and claim for refund is made by the applica
- 6) This demand notice (DC advice) pertaining to the proposed construction falls within the jurisdiction of Greater Cher Corporation.
  - 7) You are requested to furnish 5 copies of revised plan rectifying the following corrections:
    - 1. Site plan as per patta/site distinguishing the difference by hatching and setback dimensions to be shown from l boundary line.
    - 2. Balcony/w/r length to be restricted to 50% of the total building length on west & Northern side (provided: 52.75 permissible 50%).
    - 3. Solar photo voltaic system to be provided for 1/3rd of the area.
    - 4. Plot extent of sit, DC & Patta to be shown correctly.
    - 5. Area statement to be shown correctly.
    - 6. Section and elevation to be shown correctly.
    - 7. OHT above open landing to be shifted.
    - 8. Undertaking for demolition of existing building in the site under reference to be furnished.
