- ii)In cases of special Buildings, group Developments, a professionally qualified Architect Registered with the Council Architects or class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names /addresses ε consent letters should be furnished.
- iii) A report in writing shall be sent to CMDA by the Architect/class –I licensed surveyor who supervises the construction j before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to CMDA when building has reached up to plinth level and thereafter every three months at various stages of the construction/development certify that the work so far completed is in accordance with the approved plan.
