Security Deposit is refundable amounts without interest on claim, after issue of completion certificate by CMDA. If there deviation/violation/change of use of any part of /whole of the building/site to the approved plan security deposit will be fo Further, if the security deposit paid is not claimed before the expiry of five years from the date of payment, the amount w forfeited.

Security Deposit for Display Board is refundable when the display board as prescribed with format is put up in the site ur reference. In case of default Security Deposit will be forfeited and action will be taken to put up the display board.

- a. No interest shall be collected on payment received within one month (30 days) from the date of issue of the adv such payment.
- b. Payment received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annulus 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be ralong with the charges.
- c. Infrastructure and Amenities Charges shall be paid by the applicant within 30 days from the date of receipt of th demand letter, failing which in addition to the Infrastructure and Amenities Charges due, an interest at the rate of per annum for the amount due shall be paid for each day beyond the said 30 days upto a period of 90 days and that period of 90 days, an interest at the rate of 18% per annum for the amount due shall be paid by the applica
- d. Accounts Division shall work out the interest and collect the same along with the charges due.
- e. No interest is collectable for security deposit.

You are also requested to comply the following:

A. Furnish the letter of your acceptance for the following conditions stipulated by virtue of provisions available





- The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should t without prior sanction. Construction done in deviation is liable to be demolished.
 - II. In cases of Non High Rise Building, Registered Developers (RD), Registered Architects (RA), Registered El (RE), Registered Structural Engineers (RSE), Registered Construction Engineers (RCE) shall be associated construction work till it is completed.
- III. The Owner or Developer shall compulsorily appoint a Construction Engineer for over all constant superconstruction work on site and such person appointed shall not be allowed to supervise more than one such time.
- IV. The Registered Architect or Registered Engineer and the structural engineer shall be responsible for adherir provisions of the relevant and prevailing Indian Standard Specifications including the National Building Code. It they will not be held responsible for the severe damage or collapse that may occur under any natural force beyond their design courses provided in the above said Standards or National Building Code.
- V. The Registered Architect or Engineer is solely responsible for obtaining the certificate required under this rule registered professionals.
- VI. In the event of any deviations the Registered Architect or Engineer is the solely responsible to bring it to the I CMDA.
- VII. The owner or developer shall submit an application to CMDA in the first stage after completion of work up to pli requesting for issue of order for continuance of work.
- VIII. The owner or developer through the registered professional shall submit to the designated officer of CMDA a provided in the given format at the stage of Plinth and last storey level along with structural inspection reprovided.
- IX. If the services of the Registered Architect or Engineer on record are terminated he shall immediately inform about his termination and the stage of work at which his services have been terminated. The Registered Arc Engineer appointed as replacement of the preceding Registered Architect or Engineer shall inform all appointment on the job and inform CMDA of any deviation that might have occurred on the site with reference approved plan and the stage at which he is taking over the charge.
- X. The Registered Architect or Engineer appointed shall inform CMDA immediately on termination of the service registered structural engineer on record, registered construction engineer on record, or any change of c registered developer.
- XI. If during the construction of the building the owner or registered developer (RD) or Registered Architect on Record (RD) or Registered Engineer on record (ER) / Registered Structural Engineer on Record (SER) or Registered Geo T



Engineer on record (GER) or Registered Construction Engineer on Record (CER) is changed, he shall int CMDA by a registered letter that he was no longer responsible for the project, and the construction shall ha suspended until `the new Owner or Registered Developer or Registered Architect on Record (AR) etc., undert full responsibility for the project as prescribed in these rules and also in the forms.

- XII. A new owner or registered developer (RD) or Registered Architect on Record (AR) or Registered Engineer on I (ER) or Registered Structural Engineer on Record (SER) or Registered Geo Technical Engineer on record (GEI Registered Construction Engineer on Record (CER) shall inform the change to CMDA, and before taking response stated above, check as to whether the work already executed is in accordance with the Building Permit grants the competent authority. He or She may go ahead with the remaining works only after obtaining permission with
- XIII. The owner or Power of Attorney holder or registered developer or any other person who has acquired interest s submit application in complete shape for issue of completion certificate according to the norms prescribed in TN Annexure XXIII.
- XIV. The completion certificate shall not be issued unless the information is supplied by the owner, developer, the re professionals concerned in the schedule as prescribed by the competent authority from time to time.

XV.

- a) Temporary connection for water, electricity or sewer, permitted for the purpose of facilitating the cons shall not be allowed to continue in the premises after completion of the building construction.
- b) No connection to the water mains or sewer line or electricity distribution line with a building shall t without the prior permission of the authority and without obtaining completion certificate.
- c) In case, the use is changed or unauthorised construction is made, the authority is authorised to dis such services or cause discontinuance of such service.
- XVI. On completion of the construction the applicant shall intimate CMDA and shall not occupy the building or perm occupied until a completion certificate is obtained from CMDA.
- XVII.While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage he enclose a copy of the completion certificate issued by CMDA along with his application to the concept Department/Board/Agency.
- XVIII.When the site under reference is transferred by way of sale/lease or any other means to any persor completion of the construction, the party shall inform CMDA of such transaction and also the name and address persons to whom the site is transferred immediately after such transaction and shall bind the purchaser conditions to the Planning Permission.
- XIX.In the Open space within the site, trees should be planted and the existing trees preserved to the extent possible
- XX. If there is any false statement, suppression or any misrepresentations of acts in the applicant, planning permis be liable for cancellation and the development made, if any will be treated as unauthorized.
- XXI. The new building should have mosquito proof overhead tanks and wells.
- XXII. The sanction will be revoked, if the conditions mentioned above are not complied with.
- XXIII.Rainwater conservation measures notified by CMDA should be adhered to strictly.
- a) Details of the proposed development duly filled in the format enclosed for display at the site in cases of Hi Buildings.

The issue of Planning Permission depends on the compliance/fulfillment of the conditions/payments stated abc acceptance by the Authority of the pre-payment of the Development charge and other charges etc. shall not entitle the pthe Planning Permission but only refund of the Development Charge and other charges (excluding Scrutiny Fee) in a

refusal of the permission for non- compliance of the conditions stated above or any of the provisions of TNCB&DR - 201 has to be complied before getting the Planning permission or any other reason provided the construction is not commer claim for refund is made by the applicant.
