- 1. i) Security deposit are refundable amount without interest on claim, after issue of completion certificate from CMDA, if there is any deviation/change of use of any part or whole of the building/site to the approved plan, security deposit will be forfeited.
 - ii) In the event of the security deposit is not claimed within a period of 5 years from the date of remittance, the security deposit will be forfeited without any further notice.
- 2 (a). No interest shall be collected on payment received within one month (30 days) from the date of issue of the advice for such payment.
 - (b). Payment received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges.
 - (c). Infrastructure and Amenities Charges shall be paid by the applicant within 30 days from the date of receipt of this demand letter, failing which in addition to the Infrastructure and Amenities Charges due, an interest at the rate of 15% per annum for the amount due shall be paid for each day beyond the said thirty days upto a period of 90 days and beyond that period of 90 days, an interest at the rate of 18% per annum for the amount due shall be paid by the applicant.
 - (d). Accounts Division shall work out the interest and collect the same along with the charges due.
- 3. The papers would be returned unapproved if the payment is not made within 60 days from the date of issue of this letter.
 - 4. The measures stipulated by CMDA for rain water conservation to be adhered strictly.
- 5. The issue of planning Permission will depend on the compliance/fulfillment of the conditions/payments stated above.
- 6. Non -provision of Rain Water Harvest structures as shown in the approved plan to the satisfaction of the Authority will also be considered as a deviation to the approved plan and violation of DR and Enforcement action will be taken against such development.
- 7. Furnish an understanding in Rs.20/ Stamp paper agreeing to provide provisions of solar energy system by erecting solar photo voltaic panels before issue of completion certificate you are also requested to show the above provision while submitting revised plan.
- 8. You are also requested to furnish the particulars along with 5 sets of revised plans rectifying the following defects; before of pp.
 - 1. NOC from Southern Railway to be furnished.
 - 2. Undertaking abide to the conditions laid out in the Railway NOC to be furnished.

- Undertaking abide to the conditions in the DF&RS NOC letter to be furnished. 3.
- Undertaking to the effect that the required street alignment portion shall be gifted to the 4. competent authority as when the Hon'ble Court finalises the case, which shall also be confirmed at the time of issue of completion certificate, since the applicant has not proposed any access through common passage to the CTH Road for the site u/r.
- EB Room and Genset existing in the setback space on Southern side to be shifted and 5. the same shall be confirmed before issue of Planning Permission.
- Electrical Room to be provided in Ground Gloor satisfying DR requirement. 6.
- Breakup measurement to be tallied with overall building dimension as on site and 7. colouring to be shown properly differentiating the proposed and existing building.
- 8. LMR to be shown in the terrace floor plan with size.
- Profile of upperfloor to be shown correctly in the site plan and setback to be shown at 9. all crucial point.
- Bar indicated in the floor plan to be deleted and Restaurant to be mentioned in the plan 10. and title of the drawing.
- 11. Site extent to be correctly mentioned in B-Form.
- 12. Site address to be correctly mentioned in Form-C and Display Format.
- 13. The Ramp to be shown as per notation in the site plan.
- 14. The septic tank size to be shown as per the design calculation.
- 15. Over all dimension of the building to be shown in the site plan.
- The title of the plan and area statement needs correction. 16.
- 17. Solar energy capture and solar water system not shown in the terrace floor plan.
- 18. The wall to be demolished to be shown in yellow colour.
- 19. The site boundary as per site condition and Patta hatching the difference area and showing setbacks from minimum dimension line was not furnished.
- 20. Extension of License from Chennai Corporation to be obtained by the L.S. and furnished to CMDA.
- The site boundary as per patta and as on site to be mentioned, differences to be hatched 21. and setbacks to be shown from least site boundary line and breakup measurements to be tallied with over all measurements.
- 22. Area statement needs correction.
- Extension of Licensed Surveyor Thiru.R.Chandrasekaran to be furnished. 23.
- 24. As per inspection report, the site is low lying (1.2 m with reference to road). This has to be shown appropriately in section and elevation.
