To process the application you are requested to remit the following charges by separate Demand Drafts of Nationalized Bank in Chennai City drawn in favour of Member-Secretary, CMDA, Chennai- 600 008, at Cash Counter (between 10.00 A.M and 4.00 P.M) in CMDA and produce the duplicate receipt to the Area Plans Unit, CMDA, Chennai-8 (Payment can also be made through online Gateway payment of Indusland Bank in A/c No.100034132198 (IFSC Code No. INDB0000328): was examined and layout plan has been prepared to satisfy the Development Regulation requirements ar approved.

The amount remitted vide receipt No:B004959 dated 06.07.2017 in the earlier approval in file No.B3/2701/2017 has been adjusted in this revised present proposal and the following balance amount to be remitted.

The security deposit is also acceptable in the form of Bank Guarantee from any Scheduled bank having branch in Chennai Metropolitan Area, in the prescribed format for the entire period of Planning Permission.

Security Deposit is refundable amounts without interest on claim, after issue of completion certificate by CMDA. If there is any deviation/violation/change of use of any part of /whole of the building/site to the approved plan security deposit will be forfeited. Further, if the security deposit paid is not claimed before the expiry of five years from the date of payment, the amount will sta forfeited.

Security Deposit for Display Board is refundable when the display board as prescribed with format is put up in the site under reference. In case of default Security Deposit will be forfeited and action will be taken to put up the display board.

- a. No interest shall be collected on payment received within one month (30 days) from the date of issue of the advise fo such payment.
- b. Payment received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges.
- c. Infrastructure and Amenities Charges shall be paid by the applicant within 30 days from the date of receipt of this demand letter, failing which in addition to the Infrastructure and Amenities Charges due, an interest at the rate of 15% per annum for the amount due shall be paid for each day beyond the said 30 days upto a period of 90 days and beyond that period of 90 days, an interest at the rate of 18% per annum for the amount due shall be paid by the applicant.
- d. Accounts Division shall work out the interest and collect the same along with the charges due.
- e. No interest is collectable for security deposit.

The papers would be returned unapproved, if the payment is not made within 60 days from the date of issue of this letter.

You are also requested to comply the following:

- A. Furnish the letter of your acceptance for the following conditions stipulated by virtue of provisions available un TNCD&BR 2019:-
  - I. The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be  $m\epsilon$  without prior sanction. Construction done in deviation is liable to be demolished.
  - II. In cases of Non High Rise Building, Registered Developers (RD), Registered Architects (RA), Registered Engine (RE), Registered Structural Engineers (RSE), Registered Construction Engineers (RCE) shall be associated with construction work till it is completed.
  - III. The Owner or Developer shall compulsorily appoint a Construction Engineer for over all constant supervision construction work on site and such person appointed shall not be allowed to supervise more than one such site a time.
  - IV. The Registered Architect or Registered Engineer and the structural engineer shall be responsible for adhering to provisions of the relevant and prevailing Indian Standard Specifications including the National Building Code. Howethey will not be held responsible for the severe damage or collapse that may occur under any natural force go



beyond their design courses provided in the above said Standards or National Building Code.

- V. The Registered Architect or Engineer is solely responsible for obtaining the certificate required under is rule from registered professionals.
- VI. In the event of any deviations the Registered Architect or Engineer is the solely responsible to bring it to the notice CMDA.
- VII. The owner or developer shall submit an application to CMDA in the first stage after completion of work up to plinth le requesting for issue of order for continuance of work.
- VIII. The owner or developer through the registered professional shall submit to the designated officer of CMDA a progrescrificate in the given format at the stage of Plinth and last storey level along with structural inspection report provided.
- IX. If the services of the Registered Architect or Engineer on record are terminated he shall immediately inform CM about his termination and the stage of work at which his services have been terminated. The Registered Architect Engineer appointed as replacement of the preceding Registered Architect or Engineer shall inform about appointment on the job and inform CMDA of any deviation that might have occurred on the site with reference to approved plan and the stage at which he is taking over the charge.
- X. The Registered Architect or Engineer appointed shall inform CMDA immediately on termination of the services of registered structural engineer on record, registered construction engineer on record, or any change of owner registered developer.
- XI. If during the construction of the building the owner or registered developer (RD) or Registered Architect on Record (A or Registered Engineer on record (ER) / Registered Structural Engineer on Record (SER) or Registered Geo Techn Engineer on record (GER) or Registered Construction Engineer on Record (CER) is changed, he shall intimate CMDA by a registered letter that he was no longer responsible for the project, and the construction shall have to suspended until 'the new Owner or Registered Developer or Registered Architect on Record (AR) etc., undertakes full responsibility for the project as prescribed in these rules and also in the forms.
- XII. A new owner or registered developer (RD) or Registered Architect on Record (AR) or Registered Engineer on Record (ER) or Registered Structural Engineer on Record (SER) or Registered Geo Technical Engineer on record (GER) an Registered Construction Engineer on Record (CER) shall inform the change to CMDA, and before taking responsib as stated above, check as to whether the work already executed is in accordance with the Building Permit granted by the competent authority. He or She may go ahead with the remaining works only after obtaining permission with CMI
- XIII. The owner or Power of Attorney holder or registered developer or any other person who has acquired interest shall submit application in complete shape for issue of completion certificate according to the norms prescribed in TNCDB Annexure XXIII.
- XIV. The completion certificate shall not be issued unless the information is supplied by the owner, developer, the registe professionals concerned in the schedule as prescribed by the competent authority from time to time.

XV.

a) Temporary connection for water, electricity or sewer, permitted for the purpose of facilitating the construct shall not be allowed to continue in the premises after completion of the building construction.

- b) No connection to the water mains or sewer line or electricity distribution line with a building shall be me without the prior permission of the authority and without obtaining completion certificate.
- c) In case, the use is changed or unauthorised construction is made, the authority is authorised to discontinuance of such services.
- XVI. On completion of the construction the applicant shall intimate CMDA and shall not occupy the building or permit it to occupied until a completion certificate is obtained from CMDA.
- XVII.While the applicant makes application for service connection such as Electricity, Water Supply, Sewerage he sho enclose a copy of the completion certificate issued by CMDA along with his application to the concerr Department/Board/Agency.
- XVIII.When the site under reference is transferred by way of sale/lease or any other means to any person before completion of the construction, the party shall inform CMDA of such transaction and also the name and address of persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to the conditions to the Planning Permission.
- XIX.In the Open space within the site, trees should be planted and the existing trees preserved to the extent possible;
- XX. If there is any false statement, suppression or any misrepresentations of acts in the applicant, planning permission be liable for cancellation and the development made, if any will be treated as unauthorized.
- XXI. The new building should have mosquito proof overhead tanks and wells.
- XXII. The sanction will be revoked, if the conditions mentioned above are not complied with.
- XXIII.Rainwater conservation measures notified by CMDA should be adhered to strictly.
- a) Details of the proposed development duly filled in the format enclosed for display at the site in cases of High R Buildings.

The issue of Planning Permission depends on the compliance/fulfillment of the conditions/payments stated above. I acceptance by the Authority of the pre-payment of the Development charge and other charges etc. shall not entitle the persor the Planning Permission but only refund of the Development Charge and other charges (excluding Scrutiny Fee) in cases refusal of the permission for non- compliance of the conditions stated above or any of the provisions of TNCB&DR - 2019, wh has to be complied before getting the Planning permission or any other reason provided the construction is not commenced  $\varepsilon$  claim for refund is made by the applicant.

This demand notice (DC advice) pertaining to the proposed construction falls within the Jurisdiction of The Commissioner Av MPTY.

- NOC for Traffic obtained from the Commissioner of Police, Chennai to be furnished.
- To surrender Approved plan, Planning Permit and Final letter in Originals for cancellation of Earlier Planning Permission issued by CMDA.
- Detailed drawing of Commercial Swimming Pool satisfying TNCDBR to be furnished.
- · Area statement and title of the plan requires correction.
- Design calculation of septic tank with up flow filter to be shown correctly.
- Transformer yard to be shown in front side as per earlier approved plan.
- 1 in 12 PH ramp to be shown to a width of 1.80 m.
- Copy of certificate for Registered Developers to be furnished, since plot extent more than 500 sq.m and height of the building is more than 12.00 m Commercial Building.
- Existing EB room on Southern side setback space to be shifted without affecting driveway and feasible for car parking.
- Access for restaurant and reception area to be shown correctly with steps and PH ramp.
- · Level of the site to be shown correctly in floor plan, elevation and cross section.
- An undertaking to be furnished to the effect that the required Street Alignment Portion to be gifted, to the competent authority as and when the Honorable Court finalizes the case which shall also be confirmed at the time of issue of Completion Certificate since the applicant has not proposed any access through common passage to the CTH road fo the site under reference.
- In southern side compound wall to be constructed as per the least boundary line.
