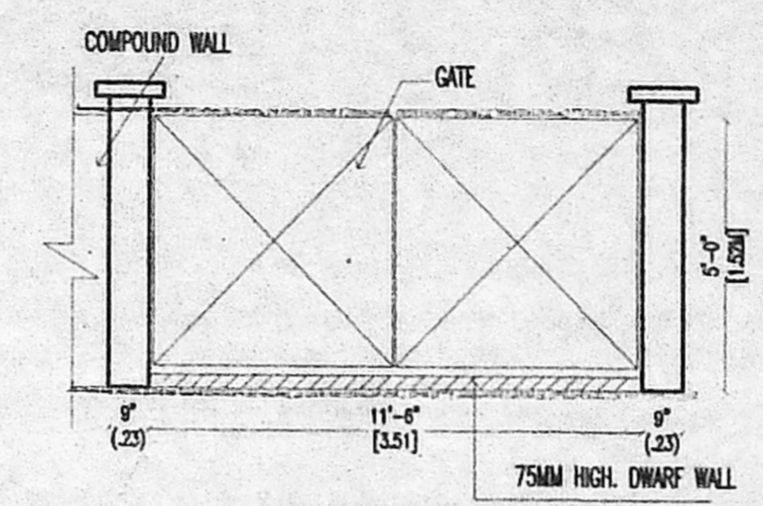
BLOCK - A  
WEST SIDE ELEVATION



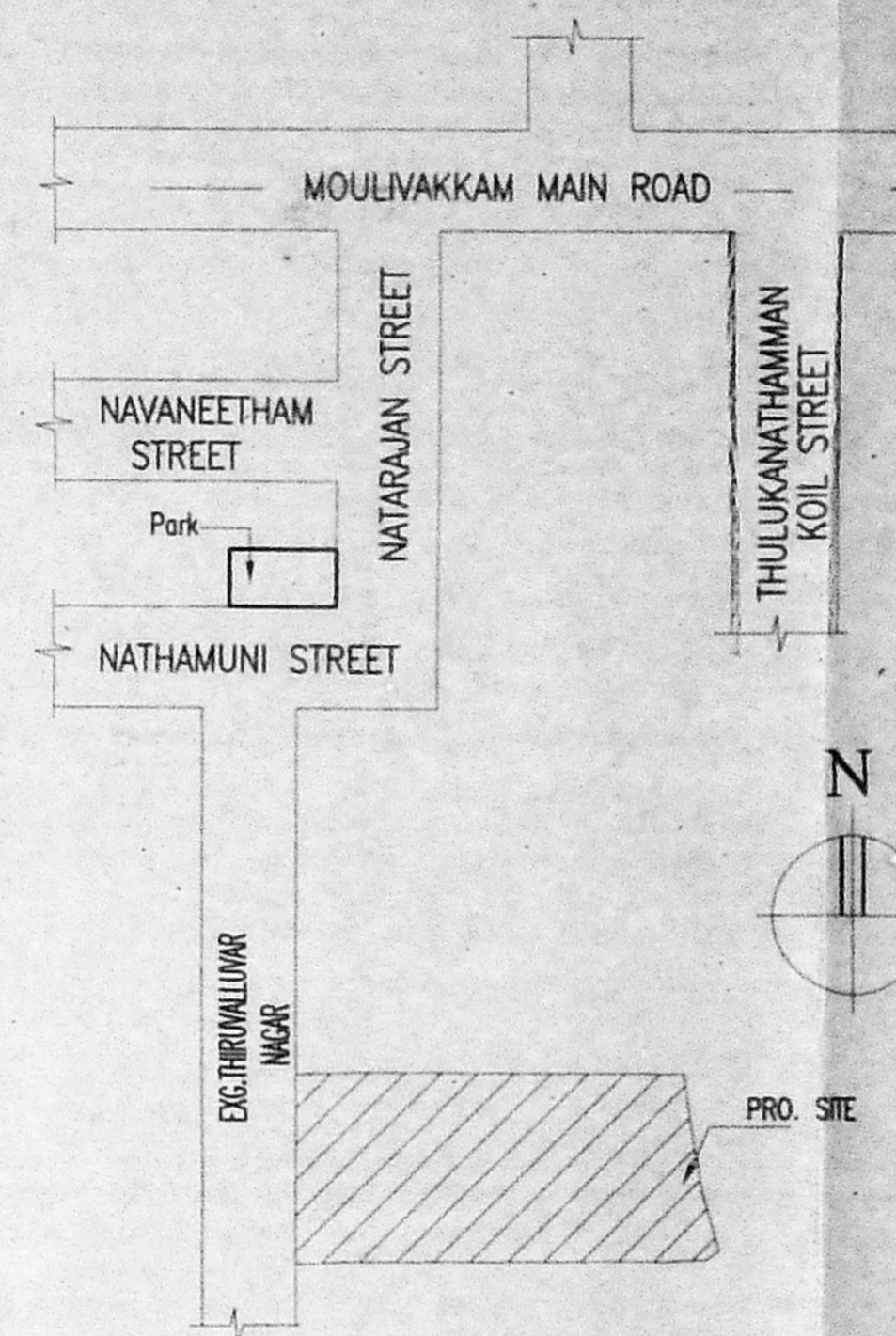

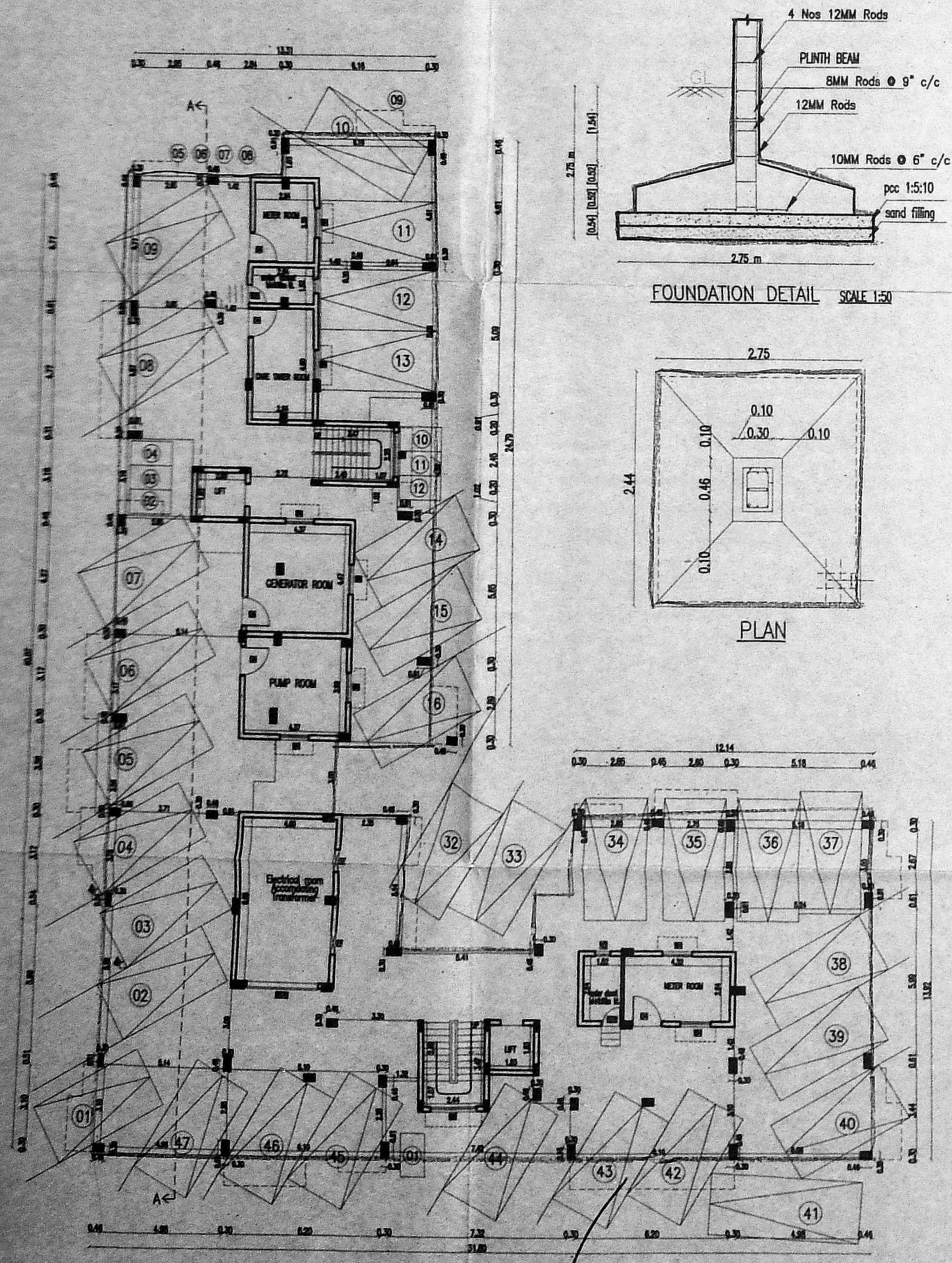
PERCOLATION PIT



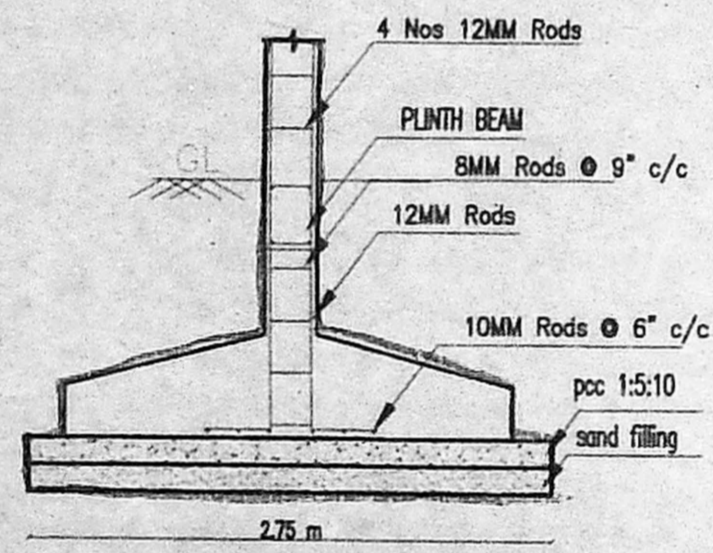
ELEVATION OF GATE AND

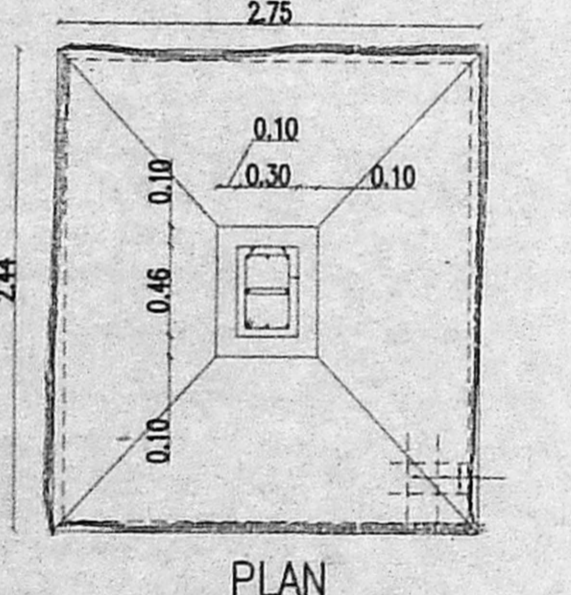

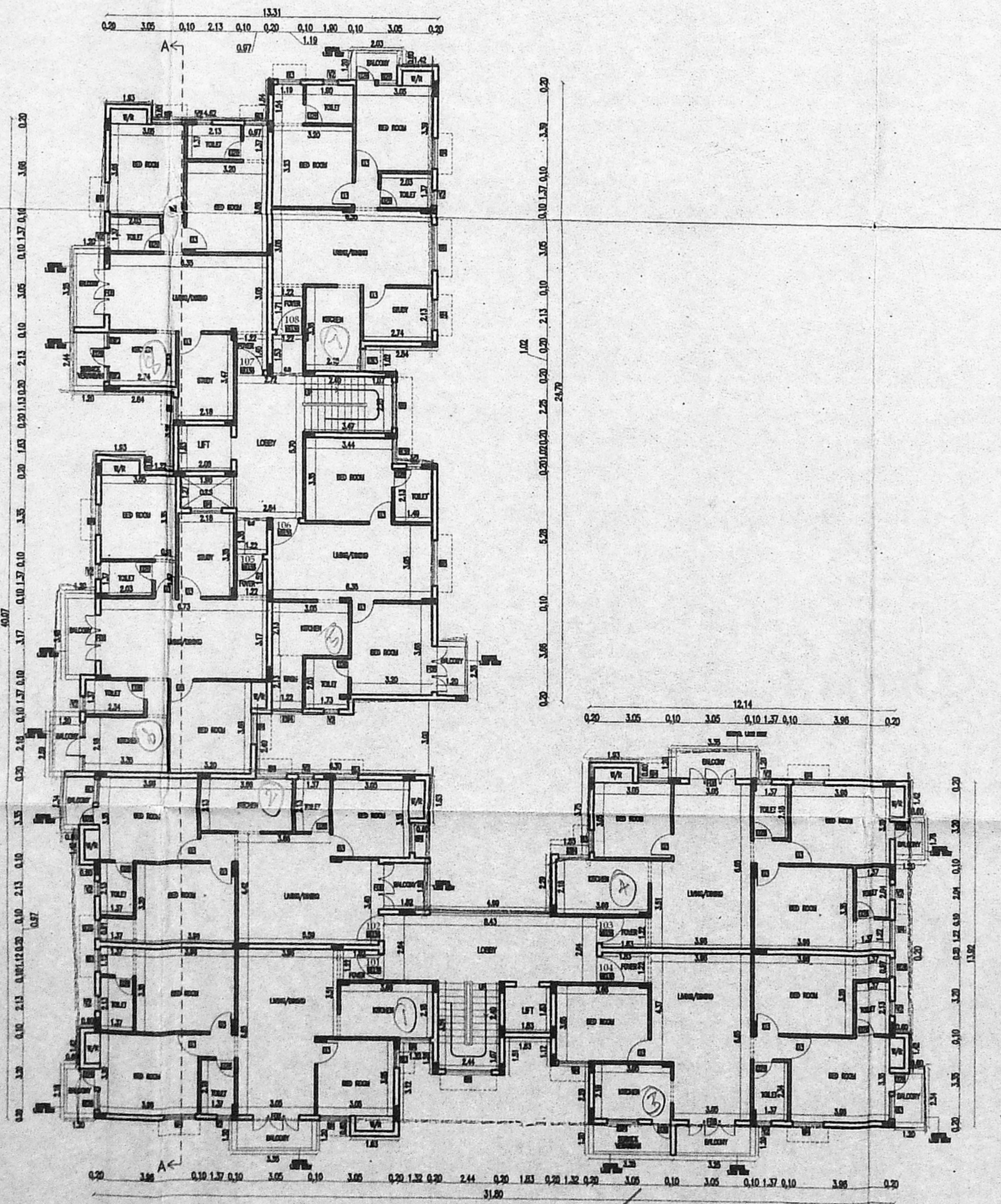
BLOCK - A  
STILT FLOOR PLAN



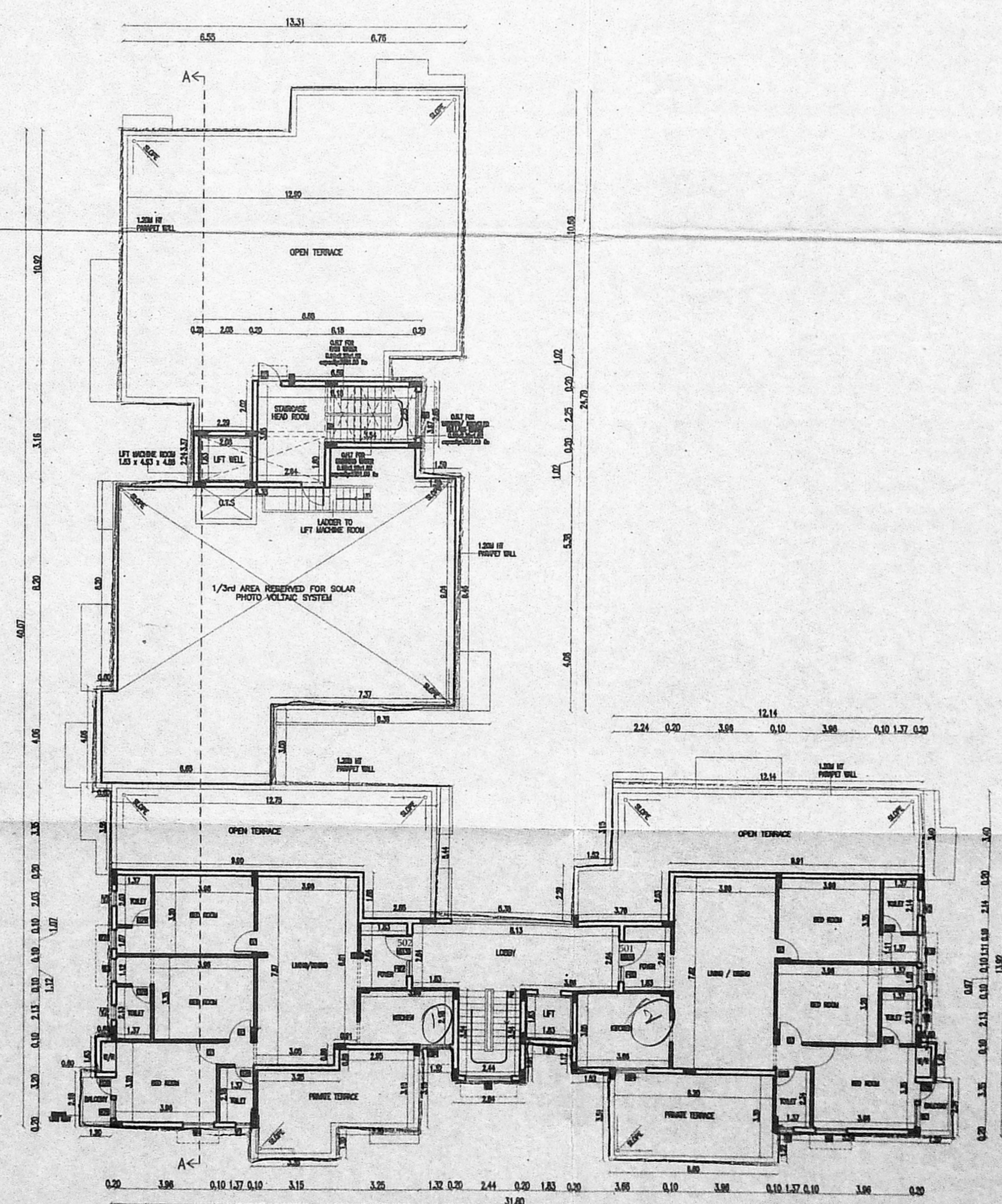

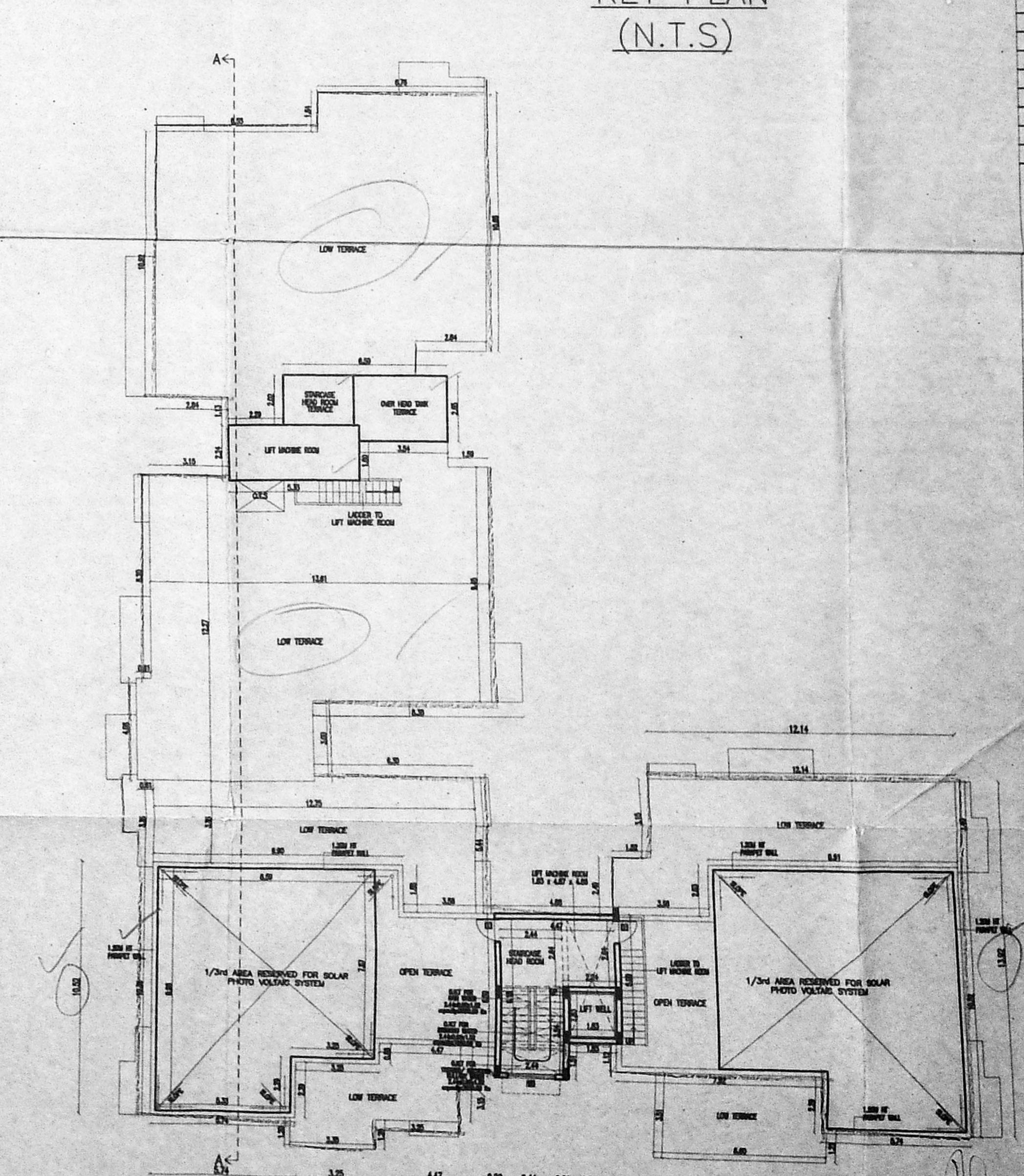
