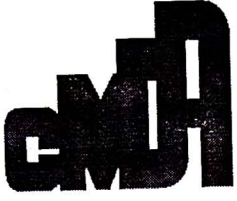

Sub: CMDA Area Plans Unit – “B” Channel (South) – Planning Permission Application for the proposed construction of Group Development – 2 Blocks comprising of Stilt floor +4 Floors + 5 floor (part) Residential building 51 Dwelling Units with Premium FSI at Plot No.2, Existing Tiruvalluvar Nagar Road, Manappakam, Chennai comprised in Old Survey No.470 (Part) (as per Doc) and New Survey No.470/2 (as per patta) of Manapakkam village within Greater Chennai Corporation – Remittance of DC & Other charges – DC advice Sent – Reg.

The Planning Permission Application received in the reference 1st cited for the proposed construction of Group Development – 2 Blocks comprising of Stilt floor +4 Floors + 5 floor (part) Residential building 51 Dwelling Units with Premium FSI at Plot No.2, Existing Tiruvalluvar Nagar Road, Manappakam, Chennai comprised in Old Survey No.470 (Part) (as per Doc) and New Survey No.470/2 (as per patta) of Manapakkam village within Greater Chennai Corporation is under process. To process the application you are requested to remit the following charges by separate Demand Drafts of a Nationalized Bank in Chennai City drawn in favour of Member-Secretary, CMDA, Chennai- 600 008, at Cash Counter (between 10.00 A.M and 4.00 P.M) in CMDA and produce the duplicate receipt to the Area Plans Unit, CMDA, Chennai-8 (or) Payment can also be made through online Gateway payment of IndusInd Bank in A/c No.100034132198 (IFSC Code No. INDB0000328):

In the reference cited the applicant paid fees are adjusted.

1. i) Security deposit are refundable amount without interest on claim, after issue of completion certificate from CMDA , if there is any deviation/change of use of any part or whole of the building/site to the approved plan, security deposit will be forfeited.
- ii) Security Deposit for display board is refundable, when the display board as prescribed in the format is put up in the site under reference. In case of default, Security Deposit will be forfeited and action will be taken to put up the Display Board.

- iii) In the event of the security deposit is not claimed within a period of 5 years from the date of remittance, the security deposit will be forfeited without any further notice.
- 2 (a) No interest shall be collected on payment received within one month (30 days) from the date of issue of the advice for such payment.
 - (b). Payment received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges.
 - (c). Infrastructure and Amenities Charges shall be paid by the applicant within 30 days from the date of receipt of this demand letter, failing which in addition to the Infrastructure and Amenities Charges due, an interest at the rate of 15% per annum for the amount due shall be paid for each day beyond the said thirty days upto a period of 90 days and beyond that period of 90 days, an interest at the rate of 18% per annum for the amount due shall be paid by the applicant.
 - (d). Accounts Division shall work out the interest and collect the same along with the charges due.
 - (e) The applicable interest for belated payment if any in respect of Shelter Fund has to be remitted.
 3. The papers would be returned unapproved if the payment is not made within 60 days from
the date of issue of this letter.
 4. You are also requested to comply the following:
 - a) The measures stipulated by CMDA for rain water conservation to be adhered
 - b) Furnish the letter of your acceptance for the following conditions stipulated by virtue of provisions available under DR 4(2)(b)
 - i) The construction shall be undertaken as per sanctioned plan only and no deviation from the plans should be made without prior sanction. Construction done in deviation is liable to be demolished.
 - ii) In cases of special Buildings, group Developments, a professionally qualified Architect Registered with the Council of Architects or class-I Licensed Surveyor shall be associated with the construction work till it is completed. Their names /addresses and consent letters should be furnished.
 - iii) A report in writing shall be sent to CMDA by the Architect/class –I licensed surveyor who supervises the construction just before the commencement of the erection of the building as per the sanctioned plan. Similar report shall be sent to CMDA when the building has reached up to plinth level and

thereafter every three months at various stages of the construction/development certifying that the work so far completed is in accordance with the approved plan.

The Licensed Surveyor and Architect shall inform this Authority immediately if the contract between him/them and the owner/developer has been cancelled or the construction is carried out in deviation to the approved plan.

- iv) The owner shall inform CMDA of any changes of the licensed Surveyor/Architect. The newly appointed Licensed Surveyor/Architect shall also confirm to CMDA that he has agreed for supervising the work under reference and intimate the stage of construction at which he has taken over. No Construction shall be carried on during the period intervening between the exist of the previous Architect/Licensed surveyor and entry of the newly appointed.
- v) On completion of the construction, the applicant shall intimate CMDA and shall not occupy the building or permit it to be occupied until a completion certificate is obtained from CMDA.
- vi) While the applicant makes application for service connection such as Electricity, Water supply, Sewerage, he/she should enclose a copy of the completion certificate issued by CMDA along with his application to the concerned Department Board/Agency.
- vii) When the site under reference is transferred by way of sale/Lease or any other means to any person before completion of the construction, the party shall inform CMDA of such transaction and also the name and address of the persons to whom the site is transferred immediately after such transaction and shall bind the purchaser to those conditions to the planning permission.
- viii) In the open space within the site, trees should be planted and the existing trees preserved to the extent possible.
- ix) If there is any false statement suppression or any misrepresentations of action the application planning permission will be liable for a cancellation and the development made, if any will be treated as unauthorized.
- x) The new building should have mosquito proof for overhead tanks and wells.
- xi) The sanction will be void abinitic if the conditions mentioned above are not complied with
- xii) Rain water conservation measures notified by CMDA should be adhered to strictly:
 - a) Undertaking (in the format prescribed in Annexure III to DR) a copy of it enclosed in Rs.10/ stamp paper duty executed by all the land owners, GPA

Holders, builders and promoters separately. The undertakings shall be duly attested by a Notary Public.

- b) Details of the proposed development duly filled in the format enclosed for display at the site in cases of Special Buildings and Group Developments.
- 5) The issue of planning permission depends on the compliance/fulfillment of the conditions/payments stated above. The acceptance by the Authority of the prepayment of the Development Charges and other charges, etc. shall not entitle the person to the planning permission, but only refund of the Development Charges and other charges(excluding Scrutiny Fee) in case of refusal of the permission for noncompliance of the conditions stated above or any of the provisions of DR, which has to be complied before getting the planning permission or any other person provided the construction is not commenced and claim for refund is made by the applicant.
- 6) This demand notice (DC advice) pertaining to the proposed construction falls within the jurisdiction of **Greater Chennai Corporation**.
- 7) You are requested to furnish the following particulars and 5 copies of revised plan rectifying the following corrections:
 - a) Additional 2 numbers of Two Wheeler to be provided in the site plan (feasible). ✓
 - b) Readable and legible copy of plan to be furnished. ✓
 - c) Site Boundary as Per FMB and as on site measurement to be shown in the site plan and setback to be shown from the least boundary as on site condition.
 - d) Rain Water harvesting to be shown as per TNCDBR 2019 and turning radius to be shown correctly in the stilt floor plan cum site plan. ✓
 - e) Breakup measurement do not tally with overall measurements in floor plans and handrail to be shown in balcony of all floor plan. ✓
 - f) Area statement, Section, Elevation and subtitle needs correction. ✓
 - g) Head room, OHT, LMR and Ladder along with measurement to be shown in the terrace floor plan and breakup measurement to be removed in the terrace floor plan. ✓
 - h) In Block B door to be removed and "Private terrace" to be renamed as "Open terrace" in the floor plan. ✓
 - i) The STP detailed drawing and calculations to be furnished and location of STP with size to be mentioned in site plan ✓

- j) Owner, Architect & Structural Engineer to be signed in the plan. *cmd applications*
- k) Registered Developer, Registered Architect, Registered Construction Engineer Certificate issued by CMDA for Registered Professional to be furnished. ✓
- l) The Owner / Developer Photo copy to affixed in the Form-B. ✓
- m) Revised Form B & Form C (undertaking in Rs.20/- stamp paper) to be furnished as per TNCD&BR. ✓
- n) To surrender earlier CMDA approved original planning permit, approved plans and final letter. ✓
