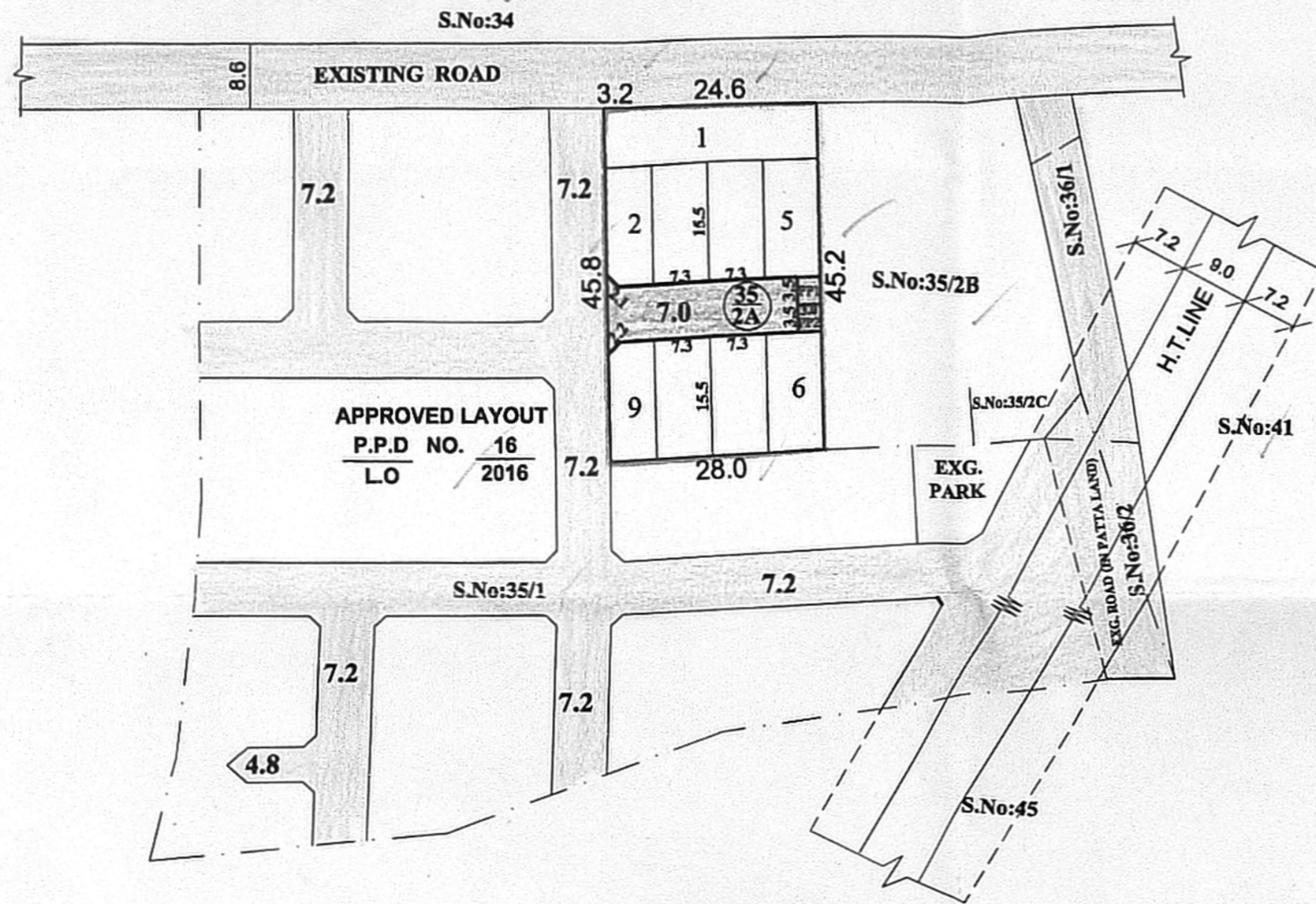
(II) TNCDBR RULE NO: 47 (11)
