iii)	Balance Scrutiny Fee	NIL
v)	Regularization charges for land	Rs.89,000/- (Rupees Eighty Nine Thousand only)
vi)	Open Space Reservation Charges under DR Annexure XX (i.e) equivalent land cost in lieu of the land to be reserved and handed over)	Does not arise

2. You are also requested to remit an amount of **Rs.500/-** (Rupees Five Hundred only) **in cash towards contribution to Flag Day Fund.**
