The proposal received in the reference 1st cited for laying out of house sites for the land comprised in S.Nos.531/2A & 2B and 537/4 part of Nandambakkam village, Pallavaram Taluk, Kancheepuram District, Kundrathur Panchayat Union limit was examined and layout has been prepared to satisfy the Tamil Nadu Combined Development & Building Rules 2019 requirements and taking into account of the existing developments around / future demand for circulation in the area. ii)	Layout preparation charges	Rs.10,000/- (Rupees Ten Thousand only)



iii)	Balance Scrutiny Fee	NIL
iv)	Regularization charges for land	Rs.1,05,000/- (Rupees One Lakh and Five Thousand Only)
v)	Open Space Reservation Charges under DR Annexure XX (i.e) equivalent land cost in lieu of the land to be reserved and handed over	Does not arise (Since the plottable area is less than 3000 sq.m.)

2. You are also requested to remit a sum of **Rs.500/- (Rupees Five Hundred only)** in cash towards contribution to Flag Day Fund.
