i)	Development charges for land under Sec.59 of T&CP Act 1971	Rs.49,000/- (Rupees Forty Nine Thousand only)
ii)	Layout preparation charges	Rs.23,500/- (Rupees Twenty Three Thousand and Five Hundred only)
iii)	Balance Scrutiny Fee	Nil
iv)	Regularization charges for land	Does not arise
v)	Open Space Reservation Charges under DR Annexure XX (i.e) equivalent land cost in lieu of the land to be reserved and handed over)	Does not arise (since OSR area of 1108 sq.m. reserved in the layout)

2. You are also requested to remit an amount of **Rs.500/-** (Rupees Five Hundred only) in cash towards contribution to Flag Day Fund.
