- 2. You are also requested to remit a sum of **Rs.500/- (Rupees Five Hundred only)** in cash towards contribution to Flag Day Fund.
- 3. Payment received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
- 4. You are also requested to furnish the following particulars as called for in the reference 4th cited:
 - i. FMB sketch for S.No.192 with incorporating the latest sub-divisions duly attested by a Revenue official not below the rank of Deputy Tahsildar.
 - ii. Citta & Adangal for the S.No.192/1 & 2 duly attested by a Revenue official (Chitta & Adangal furnished along with PPA are attested by a Notary Public only).
 - iii. Revised legal opinion for the site under reference as per the prescribed format (Annexure-C) disclosing the transaction details for every subdivisions right from the year 1975 and including the land in S.No.198 measuring 53 cents.
- 5. The papers would be returned unapproved if the payment is not made within 60 days from the date of issue of this letter.
- 6. On compliance / fulfillment of the above payment, the skeleton plan showing Road & Park area and Public Purpose site (0.5% area) to be handed over to the Local Body will be sent to the Commissioner, Kundrathur Panchayat Union @ Padappai and the balance Public Purpose site (0.5% area) to be handed over to the TANGEDCO will be sent to the Superintendent Engineer, Chennai Electricity Distribution Circle (South-I), TANGEDCO, K.K.Nagar, Chennai-78.
