- You are also requested to remit a sum of Rs.500/- (Rupees Five Hundred only) in cash towards contribution to Flag Day Fund.
- 3. Payment received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
- 4. The papers would be returned unapproved if the payment is not made within 60 days from the date of issue of this letter.
- 5. You are also requested to furnish the following particulars as called for in the ref. 4th cited:
 - i. Self-declaration in Rs.20/- stamp paper duly notarised indemnifying CMDA in the form of affidavit to the effect that he will be liable for all future consequences in case of the land falling under land ceiling, land reforms or land acquisition.
 - ii. Legal opinion on present ownership for the site under reference in the prescribed format i.e. Annexure-C issued by a Government Pleader / Additional Government Pleader / Special Government Pleader (the legal opinion furnished is issued by a Pleader doing Government Works which is not acceptable and it is also not as per the format prescribed).
- 6. On compliance / fulfillment of the above payment, the skeleton plan showing Road space, Park area and Public Purpose-1 site (0.5% area) to be handed over to the Local Body will be sent to the Executive Officer, Madambakkam Town Panchayat and the Public Purpose-2 site (0.5% area) to be handed over to the TANGEDCO will be sent to the Superintendent Engineer, Chennai Electricity Distribution Circle (South-I), TANGEDCO or to the Local Body i.e. Executive Officer, Madambakkam Town Panchayat as per your choice.
