ii)	Layout preparation charges	Rs.5,000/- (Rupees Five Thousand only)
iii)	Balance Scrutiny Fee	NIL
iv)	Regularization charges for land	-NA-
v)	Open Space Reservation Charges	-NA- (since the extent of the site is 3000 sq.m.)

2. You are also requested to remit a sum of **Rs.500/- (Rupees Five Hundred only) in cash towards contribution to Flag Day.**
