On compliance / fulfillment of the above payments, the skeleton plan showing road spaces & Public Purpose site-1 (0.5% area) to be handed over to the Local Body will be sent to the Commissioner, Kattankolathur Panchayat Union and the Public Purpose site-2 (0.5% area) to be handed over to the TANGEDCO will be sent to the Superintending Engineer, Chengalpattu Electricity Distribution Circle or to the Local Body i.e. the Commissioner, Kattankolathur Panchayat Union as per your option .
