vi)	Open Space Reservation Charges under DR Annexure XX (i.e) equivalent land cost in lieu of the land to be reserved and handed over (for 250 m ²)	Rs.18,85,000/- (Rupees Eighteen Lakhs and Eighty Five Thousand only)
