v)	Regularization charges for land	Rs.52,000/- (Rupees Fifty Two Thousand only)
vi)	Open Space Reservation Charges under DR Annexure XX (i.e) equivalent land cost in lieu of the land to be reserved and handed over) (for 38 sq.m.)	Rs.3,05,000/- (Rupees Three Lakhs and Five Thousand only)

- 2. You are also requested to remit an amount of Rs.500/- (Rupees Five Hundred only) in cash towards contribution to Flag Day Fund.
- 3. Payment received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
