 - i. Notarized self-declaration in Rs.20/- stamp paper indemnifying CMDA in the form of affidavit to the effect that she will be liable for all future consequences in case of the land falling under land ceiling, land reforms or land acquisition.
 - ii. Specific remarks on inundation point of view for the site under reference and NOC for the proposed construction of culvert across the channel obtained from PWD.
- 6. On compliance / fulfillment of the above, the skeleton plan showing road area and Public Purpose-1 site (0.5% area) to be handed over to the Local Body will be sent to the Executive Officer, Kundrathur Town Panchayat and the Public Purpose-2 site (0.5% area) to be handed over to the TANGEDCO will be sent to the Superintendent Engineer, Chennai Electricity Distribution Circle, South-I, TANGEDCO, K.K.Nagar **or** to the Local Body concerned i.e. the Executive Officer, Kundrathur Town Panchayat as per your choice, for taking over of the same through registered Gift Deed.
