- You are also requested to remit a sum of Rs.500/- (Rupees Five Hundred only) in cash towards contribution to Flag Day.
- 3. Payment received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.
- 4. The papers would be returned unapproved if the payment is not made within 60 days from the date of issue of this letter.

 - i. Chitta for the site under reference duly attested by a Revenue Official.
 - ii. Developer Registration Certificate in favour of M/s.Soundara Pandian Bone & Joint Hospital & Research Institute Private Limited represented by its Director Tmt.Usha Sivamurugan.
 - iii. Google Satellite Imagery for the site showing surrounding developments to a radius of 500 m.
 - iv. An undertaking duly notarized stating that that the site under reference is neither (i) a Water Body nor (ii) a Govt. Poramboke land executed in Rs.20/-stamp paper.
 - v. Self declaration in Rs.20/- stamp paper duly notarized indemnifying CMDA in the form of affidavit to the effect that the applicant will be liable for all future consequences in case of the land falling under land ceiling, land reforms or land acquisition (also mentioning the site address in it).
- 6. On compliance / fulfillment of the above payments, the skeleton plan showing road spaces & Public Purpose site-1 to be handed over to the Local Body will be sent to the Commissioner, Kattankolathur Panchayat Union and the balance Public Purpose site-2 to be handed over to the TANGEDCO will be sent to the Superintending Engineer, Chengalpattu Electricity Distribution Circle, Chengalpattu-613001.
