ii)	Layout preparation charges	Rs.19,000/- (Rupees Nineteen Thousand only)
iii)	Balance Scrutiny Fee	Nil
iv)	Regularization charges for land	Rs.2,80,000/- (Rupees Two Lakhs and Eighty Thousand only)
v)	Open Space Reservation Charges under DR Annexure XX (i.e) equivalent land cost in lieu of the land to be reserved and handed over (for 645 sq.m. of area)	Rs.74,50,000/- (Rupees Seventy Four Lakhs and Fifty Thousand Only)

- You are also requested to remit a sum of Rs.500/- (Rupees Five Hundred only) in cash towards contribution to Flag Day Fund.
