A Tabular statement showing the S.Nos. covered in the site under reference, its extent as per document, patta & as per the proposed layout plan, name of the present land owner, the document No. in which the present land owner inherited the property etc. duly signed by the applicant and licensed surveyor.
 - ii. Copy of Rectification Deed 1888/2020 for the sale of an extent of 25 cents in S.No.247/1D1A1 part of Agaramthen Village by the present land owner M/s.R.R.Trading Private Limited duly attested by a Notary Public.
 - iii. A-Form, Self-Declaration Affidavit and the proposed layout plan duly mentioning the correct S.Nos. with latest sub-divisions of the site under reference duly signed by both the applicants.
- 6.
