i)	Development charges for land under Sec.59 of T&CP Act 1971	Rs.13,000/- (Rupees Thirteen Thousand only)

iii)	Balance Scrutiny Fee	Nil
vi)	Regularization charges for land	Rs.80,000/- (Rupees Eighty Thousand only)

2. You are also requested to remit an amount of **Rs.500/-** (Rupees Five Hundred only) **in cash towards contribution to Flag Day Fund.**
