- You are also requested to remit a sum of Rs.500/- (Rupees Five Hundred only) in cash towards contribution to Flag Day.
- 3. Payment received after 30 days from the date of issue of this letter attracts interest at the rate of 12% per annum (i.e. 1% per month) for every completed month from the date of issue of this letter. This amount of interest shall be remitted along with the charges due.

On compliance / fulfillment of the above payments, the skeleton plan showing road space and public purpose-1 site (0.5% area) to be handed over to the Local Body will be sent to the Commissioner, Puzhal Panchayat Union and the public purpose-2 site (0.5% area) to be handed over to the TANGEDCO will be sent to the Superintending Officer, CEDC / West, TANGEDCO @ 110 KV SS Complex, Thirumangalam, Anna Nagar, Chennai - 40 or to the Commissioner, Puzhal Panchayat Union, as per your choice for necessary further action on handing over of the Road space, Park area and PP sites (1 & 2) through registered Gift Deed.
