The proposal received in the reference 1<sup>st</sup> cited and revised plan received in the reference 5<sup>th</sup> cited for sub-division of house sites in S.No.246/2 of Agaramthen Village, Tambaram Taluk, Chengalpattu Taluk, St.Thomas Mount Panchayat Union limit was examined and the sub-division plan has been prepared to satisfy the Tamil Nadu Combined Development and Building Rules, 2019 requirements and taking into account of the existing developments around / future demand for circulation in the area.
