The proposal received in the reference 1<sup>st</sup> cited for laying out of house sites in 240/1B, 4A1B1, 4A2A, 4A2C, 9A, 9C, 9E & 13 of Ayalchery Village (Sorancheri-A Village as per patta), Poonamallee Taluk, Thiruvallur District, Poonamallee Panchayat Union limit was examined and layout has been prepared to satisfy the Tamil Nadu Combined Development & Building Rules, 2019 requirements and taking into account of the existing developments around / future demand for circulation in the area. On compliance / fulfillment of the above payment, the skeleton plan showing road widening area and Public Purpose-1 site (0.5% area) to be handed over to the Local Body will be sent to the Commissioner, Poonamallee Panchayat Union and the Public Purpose-2 site (0.5% area) to be handed over to the TANGEDCO will be sent to the Superintendent Engineer, Chennai Electricity Distribution Circle (West), TANGEDCO, Thirumangalam, Anna Nagar, Chennai-40 or to the Local Body i.e. the Commissioner, Poonamallee Panchayat Union, as per your choice for taking over of the same through registered Gift Deed.
