Miles es The proposal received in the reference 1st cited for laying out of house sites comprised in S.Nos.459/381 & 460/2 of Kundrathur 'B' Village, Kundrathur Taluk, Kancheepuram District, Kundrathur Town Panchayat Limit was examined and layout plan has been prepared to satisfy the Development Regulation requirements and taking into account of the existing developments around / future demand for circulation in the area.
