The proposal received in the reference 1st cited for laying out of house sites comprised in S.Nos.459/~~3B1~~^{3B} & 460/2 of Kundrathur 'B' Village, Kundrathur Taluk, Kancheepuram District, Kundrathur Town Panchayat Limit was examined and layout plan has been prepared to satisfy the Development Regulation requirements and taking into account of the existing developments around / future demand for circulation in the area. 2. You are also requested to remit an amount of **Rs.500/-** (Rupees Five Hundred only) **in cash towards contribution to Flag Day Fund.**

On compliance / fulfillment of the above, the skeleton plan showing road area and Public Purpose-1 site (0.5% area) to be handed over to the Local Body will be sent to the Executive Officer, Kundrathur Town Panchayat and the Public Purpose-2 site (0.5% area) to be handed over to the TANGEDCO will be sent to the Superintendent Engineer, Chennai Electricity Distribution Circle, South-I, TANGEDCO, K.K.Nagar or to the Local Body concerned i.e. the Executive Officer, Kundrathur Town Panchayat as per your choice, for taking over of the same through registered Gift Deed.
