On compliance / fulfillment of the above payment and receipt of particulars from the applicant, the skeleton plan showing the Public Purpose -1 site (0.5% area reserved for Local Body) and the Public Purpose-2 site (0.5% area- reserved for TANGEDCO) will be sent to the Commissioner, Kattankolathur Panchayat Union for taking over of the same through registered Gift Deed.
