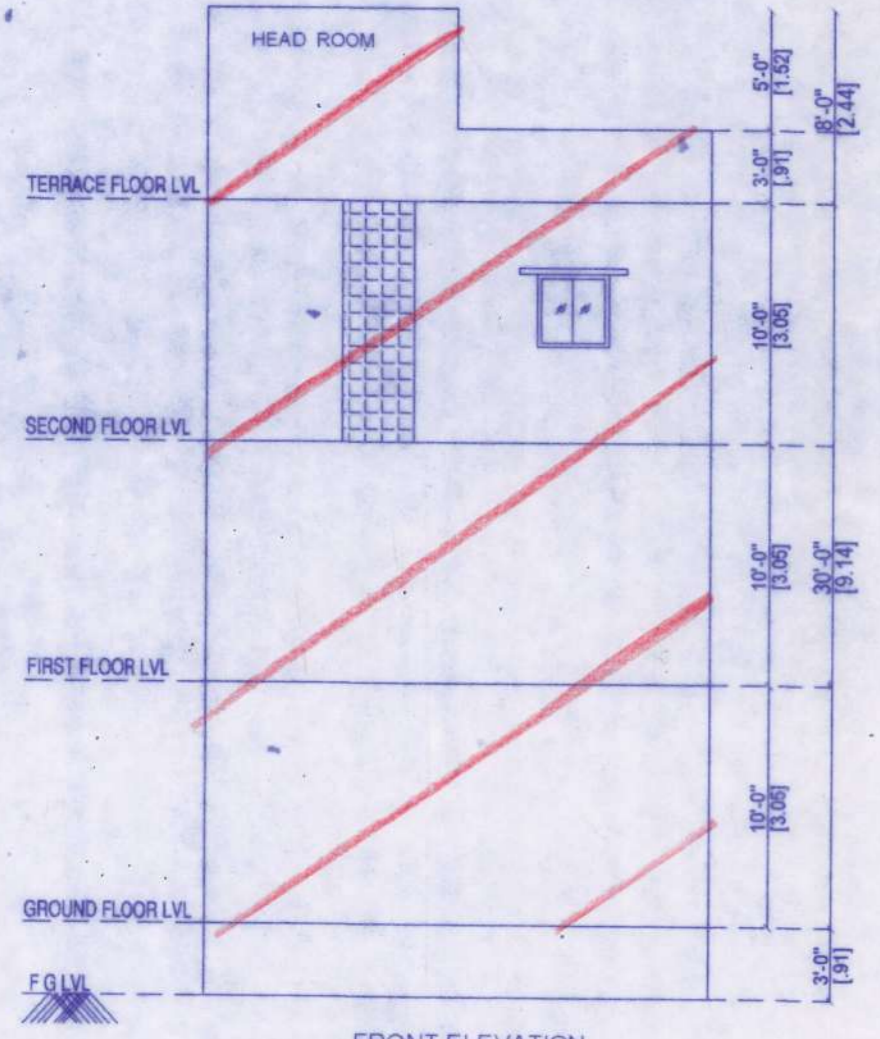

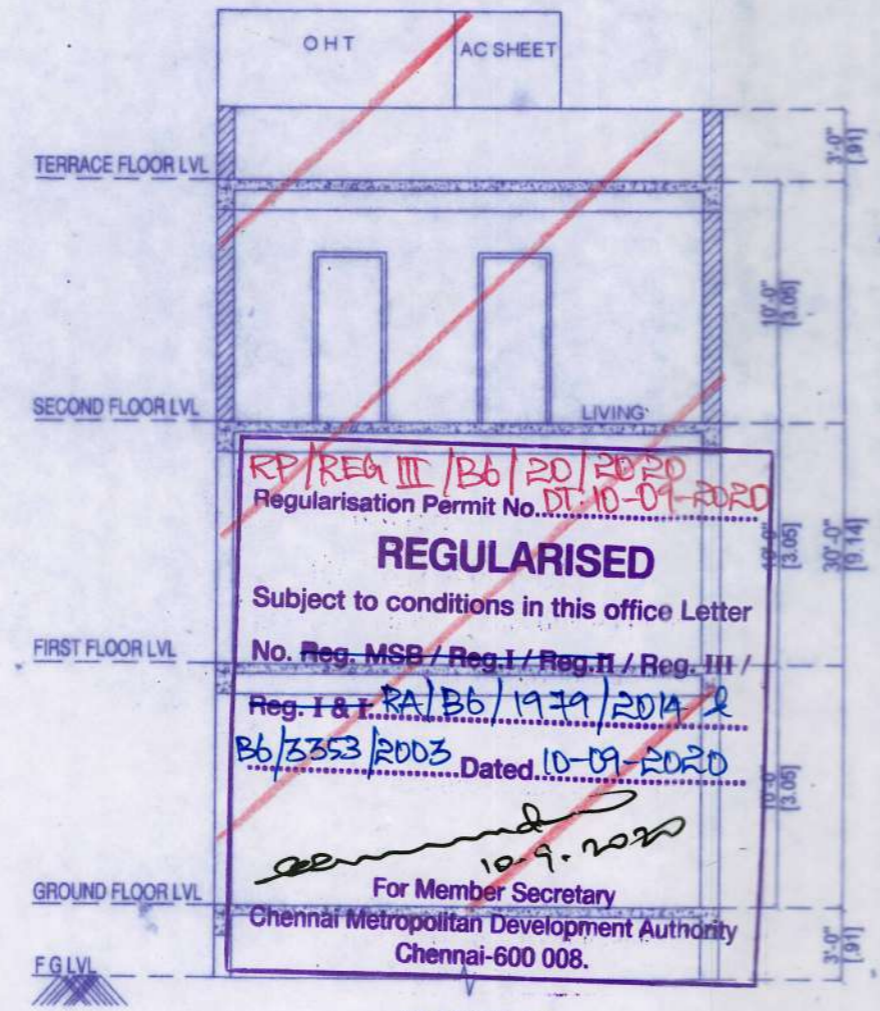

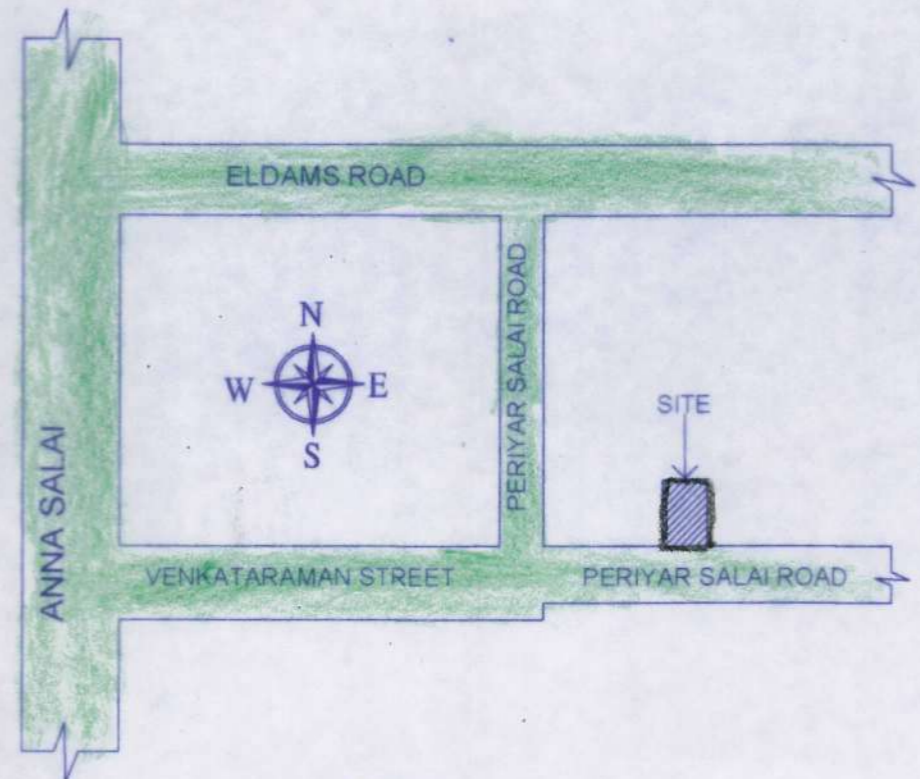


FRONT ELEVATION

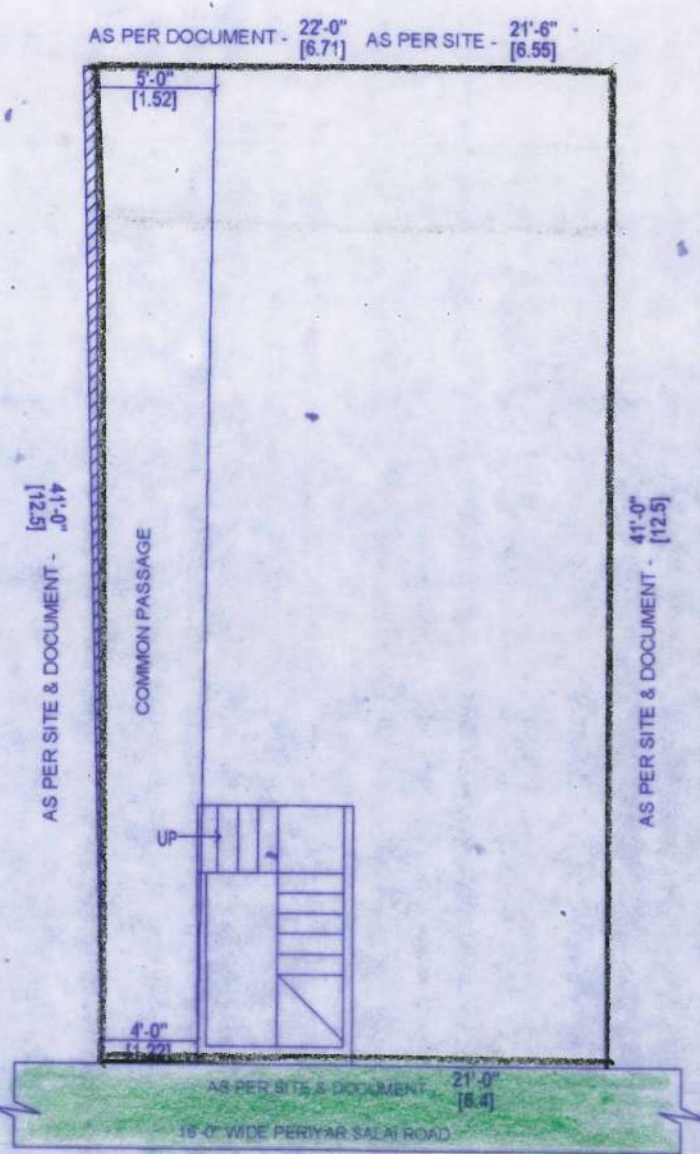

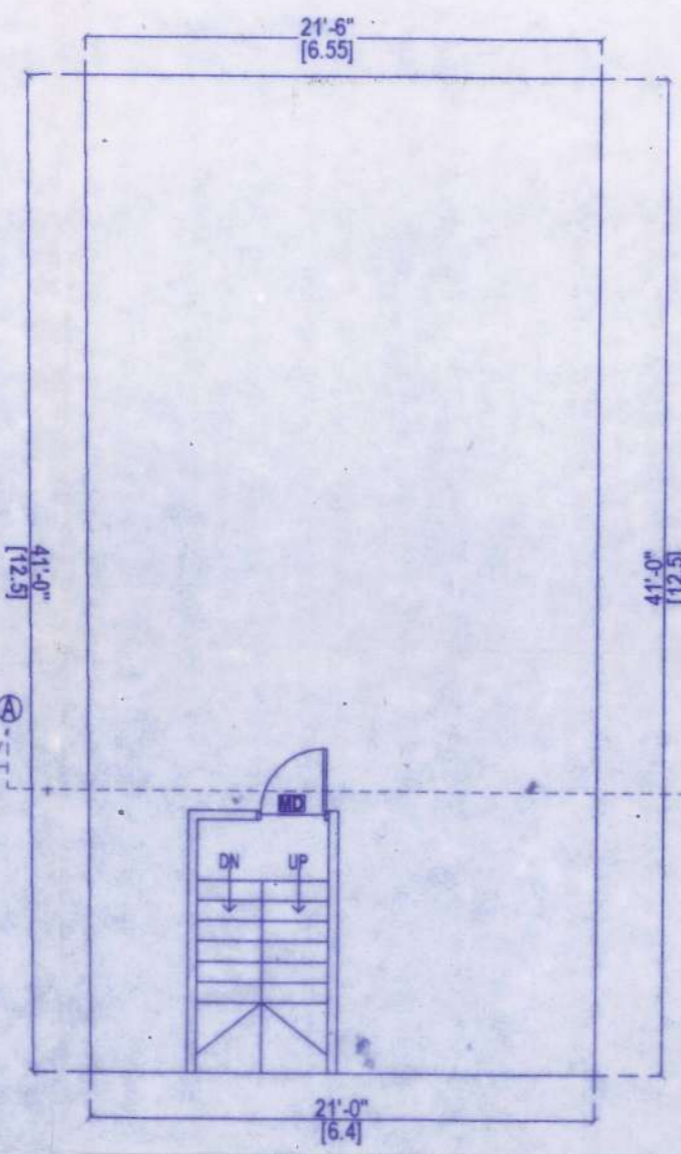

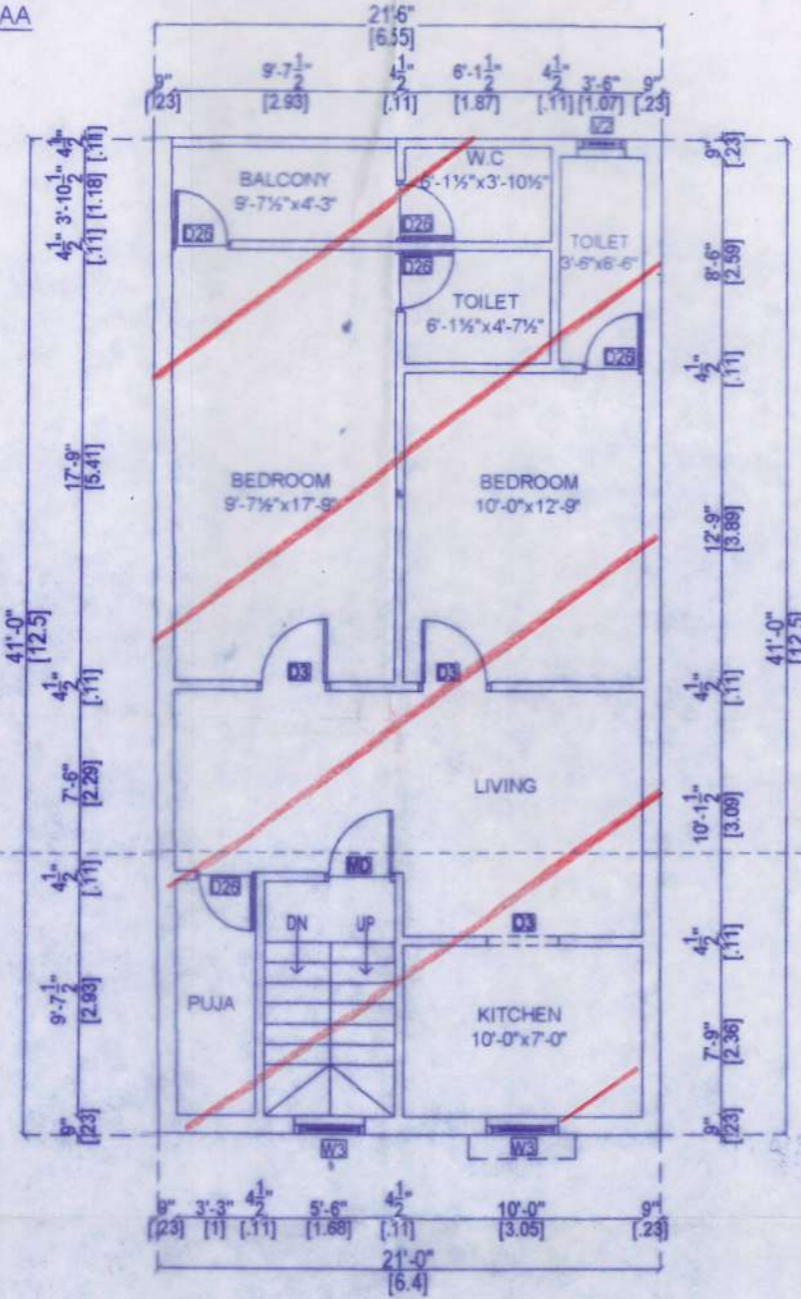
KEY PLAN  
(NO TO SCALE)



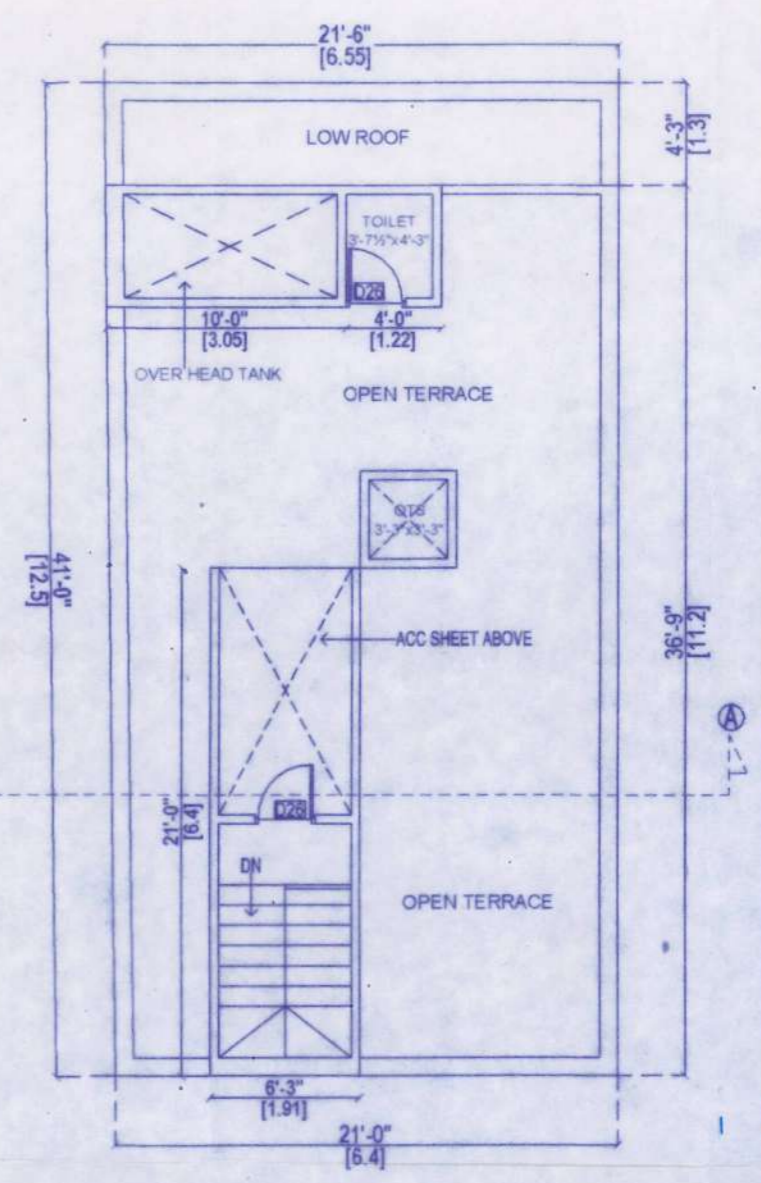
SITE CUM GROUND FLOOR PLAN
