- (I) THE FOLLOWING CONDITIONS OF WRD VIDE THE CE, WRD, CHENNAI REGION, CHEPAUK, CHENNAI-5. LETTER NO.T5(3)/10452/2010/DT:15.07.2010 ARE TO BE COMPLIED BY THE APPLICANT BEFORE ISSUING OF THE LAYOUT APPROVAL BY THE COMPETENT AUTHORITY (LOCAL BODY).
  - (1) THE PROPOSED SITES SHOULD BE RAISED TO THE LEVEL OF (+) 25.990M (CHOLAMBEDU ROAD LEVEL (+) 25.090M PLUS 0.90M) UNIFORMLY WITH HARD EARTH WITH PROPER CONSOLIDATION TO AVOID INUNDATION DURING FLOODS.
  - (2) THE PROPOSED SITE IS ABUTTING THE WATER SPREAD AREA OF THE TANK AND IT SHOULD NOT BE ENCROACHED BY THE PROMOTER.


