NO.DB/T5(3)/F-I-PARIVAKKAM/2019, DATED 11.06.2019 (AMENDING FEW CONDITIONS) ARE TO BE COMPLIED BY THE APPLICANT BEFORE ISSUING OF THE LAYOUT APPROVAL BY THE COMPETENT AUTHORITY (LOCAL BODY). 1) THE EXISTING GROUND LEVEL OF THE SITE SHOULD BE RAISED TO MINIMUM LEVEL OF (+)20.980M (i.e)0.90M ABOVE THE WEIR CREST LEVEL (+)20.080M OF VEERARAGAVAPURAM TANK WITH FILLING VARIES FROM 1.67M TO 3.50M WITH LAYERS OF NOT MORE THAT 0.30METRE DEPTH TO ACHIEVE REQUIRED DEGREE OF COMPACTION TO THE ENTIRE AREA OF THE APPLICANT LAND TO AVOID INUNDATION DURING THE HEAVY RAINS. THE ALL-ROUND PAVEMENT LEVEL WITHIN SITE SHOULD NOT BE LESS THAN (+)20.980M. 2) THE APPLICANT SHOULD PREPARE THE LAYOUT PROPOSAL BY CONSIDERING THE SUITABLE INTERNAL STORM WATER DRAINAGE NET WORK (PERIPHERAL & LATERAL), RAINWATER HARVESTING, AND SEWAGE ALIGNMENT & GARBAGES/DEBRIS AND OTHER SOL WASTE MANAGEMENT AS PER NORMS IN EXISTENCE WITHIN THE APPLICANT LAND ACCORDING TO THE EXISTING RULES IN FORCE AND SHOULD GET PROPER APPROVAL FROM THE COMPETENT AUTHORITY WITHOUT FAIL. THE SEWAGE OR ANY UNHYGIENIC DRAINAGE SHOULD NOT BE LET INTO THE DRAIN/SURPLUS COURSE AT ANY COST AND THE DEBRIS AND OTHER MATERIALS SHOULD NOT BE DUMPED INTO THE DRAIN/SURPLUS COURSE OBSTRUCTING FREE FLOW OF WATER. TO APPLICANTS SHOULD MAKE DRAIN NETWORKS AT THEIR OWN COST AND THE SAME IS TO BE CONNECTED TO THE NATURAL STORM WATER DRAINAGE OR CHANNEL/SURPLUS COURSE. 3) THE APPLICANT SHOULD CLEARLY DEMARCATE THEIR BOUNDARY ESPECIALLY ON THE NORTHERN SIDE ABUTTING THE SURPLUS COURSE IN S.NO.111, 107, 64, 59, 58, 5, 4, 2 & 1 OF PARIVAKKAM VILLAGE AND ALSO RUNNING THROUGH APPLICANT PATTA LAND BEARIN S.NO.63 OF PARIVAKKAM VILLAGE WHICH IS IN BETWEEN GOVERNMENT PORAMBOKE LANDS VIDE BEARING S.NO.64 & 59. THE SURPLUS COURSE WIDTH IN S.NO.64 IS 181.80M IN WESTERN SIDE & 59.40M IN EASTERN SIDE AS PER REVENUE RECORDS. HENCE, TH APPLICANT SHOULD GRANT THE LAND FOR FORMATION OF SURPLUS COURSE OF WIDTH 30M ON WESTERN SIDE AND 28M OF EASTERN SIDE FOR A LENGTH OF 35.60M IN HIS OWN LAND S.NO.63 OF PARIVAKKAM VILLAGE COMPULSORILY FOR FREE FLOW OF SURPLUS WATER FROM VEERARAGAVAPURAM TANK IN ORDER TO PROTECT FROM INUNDATION, BEFORE THE COMMENCEMENT OF ANY DEVELOPMENTAL ACTIVITIES IN PRESENCE OF REVENUE AUTHORITIES AND PWD/WRD AUTHORITIES CONCERNED WITHOUT FAIL A SHOULD NOT ENCROACH THE CHANNEL/RIVER ABUTTING THE LAND. THE NECESSARY SETBACK DISTANCE SHOULD BE PROVIDED AS PER THE NORMS IN EXISTENCE AND AS PER THE RULES IN FORCE OF CMDA (NOT LESS THAN 5M). DURING PREPARATION OF LAYOU

THE APPLICANT SHOULD NOT OBJECT TO PROVIDE TO FACILITATE ACCESS TO THE SITE WITHOUT ANY HINDRANCE TO THE MOVEMENT OF HEAVY MACHINERY CARRYING THE MAINTENANCE/IMPROVEMENT/DEVELOPMENT WORKS BY PWD/WRD IN FUTURE 4) THE WIDTH OF THE SURPLUS COURSE EARMARKED IN THE FMB SKETCH SHOULD BE MAINTAINED WITHOUT ENCROACHING AS PER REVENUE RECORDS & MEASUREMENTS AND ALSO SHOULD MAINTAIN THE HYDRAULIC PARAMETERS OF THE SURPLUS COURSE. IF A DAMAGES OCCURRED TO THE SAID COURSE, IT SHOULD BE RESTORED TO THE ORIGINAL STANDARDS AT THEIR OWN COST. 5) THE SURPLUS COURSE IN S.NO.111, 107, 64, 59, 58, 5, 4, 2 & 1 INCLUDING IN PATTA LAND S.F.NO63 OF SIZE SURPLUS COURSE OF WIDTH 30M ON WESTERN SIDE AND 28M ON EASTERN SIDE FOR A LENGTH OF 35.60M OF PARIVAKKAM VILLAGE ALONG THE BOUNDARY ( APPLICANTS LAND SHOULD BE COMPLETELY DESILTED AND RESECTIONED BY CONSTRUCTING RETAINING WALL ON EITHER SIDE AS WELL AS BED LINING CONCRETE OF THE DRAIN AS PER THE FMB AT THE APPLICANTS OWN COST. THE BED LEVEL OF THE ABOV COURSE SHOULD BE ASCERTAINED AND RESTORED BEFORE COMMENCING THE DEVELOPMENT ACTIVITY IN THE PRESENCE OF THE CONCERNED PWD/WRD EXECUTIVE ENGINEER. MOREOVER THE WIDTH OF ENTIRE FIELD DRAIN AS PER REVENUE RECORDS (FMB) ALON & WITHIN THE STRETCH OF APPLICANT'S LAND SHOULD BE MAINTAINED PROPERLY WITHOUT ANY CHANGE AND NO ENCROACHMENTS. THE WORK SCHEDULE FOR THE ABOVE PROPOSAL SHOULD BE INFORMED TO THE EXECUTIVE ENGINEER, PWD, WRD, KOSASTHALAIAYAR BASIN DIVISION, THIRUVALLUR FOR MONITORING AND ALSO COMPLETION OF CULVERT SHOULD BE REPORTED TO THE EXECUTIVE ENGINEER. 14) THE APPLICANT SHOULD PAY AN ANNUAL LEASE RENT OF RS.66,000/- (RUPEES SIXTY SIX THOUSAND ONLY) FOR UTILISING GOVERNMENT LAND OF 405SQ.M IN THE SHAPE OF DEMAND DRAFT DRAWN INFAVOUR OF THE EXECUTIVE ENGIEER, PWD., WRD KOSASTHALAIYAR BASIN DIVISION, THIRUVALLUR AND IT SHOULD BE PAID AT ONE LUMPSUM FOR THREE YEARS OF RS.1,98,000/- (RUPEES ONE LAKH AND NINETY EIGHT THOUSAND ONLY) IN ADVANCE BEFORE THE COMMENCEMENT OF WORK. DURING EXECUTION AFTER CONSTRUCTION OF ABOVE CULVERT, IF ANY DEVIATIONS ARE NOTED IN ABOVE MEASUREMENTS ACCORDINGLY THE LEASE RENT ALSO IS REVISED RESPECTIVELY. 15) THE APPLICANT HAS TO PAY SERVICE TAX, GST EXT., SEPARATELY AS PER NORMS IN EXISTENCE AND AS AMENDED FROM TIME TO TIME WITHOUT FAIL

16) THE APPLICANT SHOULD EXECUTE THE LEASE AGREEMENT WITH THE EXECUTIVE ENGINEER, PWD., WRD., KOSASTHALAIYAR BASIN DIVISION, THIRUVALLUR BEFORE COMMENCING THE WORK AND IT SHOULD BE RENEWED ONCE IN THREE YEARS FOR WHICH THE APPLICANT VOLUNTARILY HAS TO APPLY WITHIN 2 MONTHS, BEFORE THE EXPIRY OF THE LEASE PERIOD. THE LEASE RENT IS SUBJECTED TO REVISION FROM TIME TO TIME AS PER GUIDELINE VALUE / GOVERNMENT ORDERS. 7) THE APPLICANT HAS TO PAY THE CAUTION DEPOSIT OF SUM OF RS.2,00,000/- (RUPEES TWO LAKH ONLY) IN FAVOUR OF THE EXECUTIVE ENGINEER, PWD, WRD, KOSASTHALAIYAR BASIN DIVISION, THIRUVALLUR, WHICH WILL BE REFUNDED ONLY AFTER COMPLETION ( SIX MONTHS ON THE CERTIFICATE FROM CONCERNED ASSISTANT EXECUTIVE ENGINEER OF THIS DEPARTMENT STATING THAT THE CONSTRUCTION WORK WAS COMPLETED WITHOUT ANY DAMAGE TO THE GOVERNMENT PROPERTY OR THE DAMAGE CAUSED DURING EXECUTION IF ANY, WILL BE RECTIFIED FULLY BY THE APPLICANT.
