

(I) THE FOLLOWING CONDITIONS OF PWD VIDE THE CE, WRD, CHENNAI REGION, CHEPAUK, CHENNAI -5. LETTER NO.DB / T5(3) / 011953 / F- NOC (MADURAIPAKKAM VILLAGE) / 2022 / DATED 16.12.2022, ARE TO BE COMPLIED BY THE APPLICANT BEFORE ISSUING OF THE LAYOUT APPROVAL BY THE COMPETENT AUTHORITY (LOCAL BODY)

1 The applicants land should be filled with earth filling with proper compaction to the minimum level of (+)10.220m (ie) 0.310m above Crest Level of Weir in Maduraipakkam Tank (+) 9.910m To protect the site from inundation during floods The process of earth filling and compaction should be done in layers of not more than 0.30 metre depth to achieve required degree of compaction for the depth from (+)0.950 m to (+)1.240 m depending upon the existing field levels Also, the applicants should provide emergency pumping operation for the seepage water, if it is proposed to have basement

2. The all round pavement level within the site should not be less than (+)10.220m. The applicants should prepare the layout proposal by considering the suitable internal storm water drainage network drain as micro drains (ie) the peripheral drain size not less than the 0.90m x 0.75m and lateral drain of suitable size within the site as per site condition. The same should be connected to the local drain / channel, rainwater harvesting roads with road side drain and sewerage treatment plant and its disposal and garbages / debris and other solid waste management as per norms in existence within the applicant's land according to existing rules in force and should get proper approval from competent authority without fail.

3. The necessary setback distance should be provided with in the site as per site condition as per the norms in existence and as per the rules in force of CMDA (as per the circular issued by the office of the Commissioner of Town & Country Planning, Chennai - 2 vide Roc. No. 4367/2019-BA2 / Dated 13.03 2019) during development and there should not be any construction activities in future also, the CMDA should issue completion certificate only after obtaining compliance certificate NOC from WRD

6. The WRD officers should be allowed to inspect the site at any time during execution and thereafter, if necessary Advance intimation should be given to the WRD officers concerned before commencement of work

7. The applicants should abide by the rules and regulation of the WRD from time to time. The applicants should also abide court of law of both State & Central Government from time to time

9. WRD is giving opinion only in connection with the inundation aspect and does not deliver any rights to the applicants to encroach the WRD/ Government Lands/river. The NOC for this site from the WRD is purely issued on the basis of inundation point of view

10. The sewage water from the applicant land should not let into the drain and for the disposal of the sewage water, suitable arrangements should be made for the same by the applicants, and as well as the construction matenals/debris/garbages should not be dumped into the channel/river/tank at any


At any cost, sewage / sullage should not be let into channel/river and the garbages, debris and construction materials should not be dumped into the channel/riverrestricting the free flow of water
