The existing ground level of the site should be raised to minimum level of (+) 32.540m (i.e) 2.23m above the still level of Korattur head sluice as (+) 30.310m, with filling varies from 0.62m to depth to achieve required degree of compaction to the entire area of the applicant land to avoid inundation during the heavy rains. The all-around pavement level within site should not be less that not be below MFL. Also, the applicant should provide emergency pumping operation for the seepage water, if it is proposed to have basement floor and as well as dewatering arrangements during 2. The applicant should clearly demarcate the boundary of their land before commencement of any developmental activities in the presence of Revenue authorities and WRD authorities . The appli the Revenue records without any encroachments and should be maintained as per Revenue records (FMB).

3. The permission granted to the applicants, should not be altered/modified/changed to any others. Based on the records submitted by the applicants, the permission is granted. If any documents future the above permission will be cancelled without any correspondence. Hence the applicants are solely responsible of genuinety of the documents submitted.

4. The WRD officers should be allowed to inspect the site at any time, during execution and thereafter, if necessary. Advance intimation should be given to the WRD officers concerned before comm 5. a. The applicant should prepare the layout proposal by considering the suitable internal storm water drainage network drain as micro drains of suitable size within the site as per site condition. Rainwater harvesting, roads with road side drain and sewerage treatment and its disposal and garbages/debris and other solid waste management as per norms in existence within the force and should get proper approval from competent authority without fail.

The sewage or any unhygienic drainage(Treated or untreated) should not be let into drain/ channel/course at any cost and the debris and other materials should not be dumped into the water. The applicants should get clearance certificate for this site from the Revenue Department to make sure that the site is not an encroached properly from the water body as well as confirming this d.
