- 7) The Local Body shall regularize the individual plot in conformity with Annexure-XI [DR No.24(2)(b)] to the Development Regulations of Chennai Metropolitan Area and G.O.Ms.No.144 H&UD Dept. Dated 24.10.2018 in respect to Aquifer Recharge Area.
